## Coalition offers a reason to be thankful

■ Annual event ensures people in need have a holiday meal

The Hollywood Food Coalition and Television City made the Thanksgiving holiday special for approximately 300 people on Nov. 27 during the second annual community dinner.

The Hollywood Food Coalition provides meals and resources for people experiencing homelessness and food insecurity, serving meals on weekdays at its headquarters at the Salvation Army campus at 5939 Hollywood Blvd. and on weekends at a mobile operation at Orange Drive and Romaine Street. The special Thanksgiving dinner was held for the second year in a row at Television City, bringing together service providers and volunteers to help make a difference.

“What I love about this event for Thanksgiving is that we’re bridging all these worlds and bringing them together,” said Arnali Ray, executive director of the Hollywood Food Coalition.

“In a world that’s super divisive and so polarizing right now, it’s just a wonderful thing to see people from all walks of life coming together and enjoying the space together.”

The coalition reached out to social service partners to invite people to the Thanksgiving Community Dinner. Ray said hunger remains a significant prob-

lem, with one-in-four families in Los Angeles facing food insecurity. The Hollywood Food Coalition was founded in 1987 to address hunger, and has evolved over the years. It now serves 600 meals daily at its Hollywood headquarters.

The nonprofit uses food provided by more than 600 donors



## Measure G, A approval puts board in motion

■ Supervisors approve task force, study on homelessness

After Measure G's resounding victory on the Nov. 5 ballot, steps are already in place to put its initiatives forward, as the proposition aims to expand both the scope and transparency of Los Angeles County's governance. On Nov. 26, the Los Angeles County Board of Supervisors approved the structure for the Governance Reform Task Force, a move heralded by Supervisor Chair Lindsey Horvath, 3rd District.

“I am proud to be part of a board of all women leaders who bring thoughtful solutions to the table to ensure we get this right,” Horvath said. “This is truly the start of a process with robust public engagement at its core. Our communities will see the change this spring through transparent budget hearings, and through our soon-to-be-selected Governance Reform Task Force, our communities will have a body to engage in shaping a more transparent, accountable and representative Los Angeles County for all.”

# Padilla serves 'the spirit of Los Angeles'

■ Project Angel Food prepares Thanksgiving feasts for those in need

Sen. Alex Padilla (D-Calif.) stopped by Project Angel Food Nov. 27 to kick off the nonprofit's Thanksgiving drive. The organization, which provides medically tailored meals to people in need, is particularly busy each November as it works to ensure every client has a healthy, festive holiday.

"I grew up with a lot of community service. That's how my parents raised us," Padilla said.

Padilla is a Los Angeles County native, having grown up in Pacoima and graduating from San Fernando High School. For many years he served on the Los Angeles City Council and in the State Senate's 20th district. Prior to becoming a U.S. senator, he was California secretary of state.

Padilla brought his wife Angela and one of his sons, Diego, along to help put together meals at Project Angel Food's temporary Lincoln Heights kitchen. The organization is currently constructing a new expanded facility in Hollywood.

"It's an opportunity to raise our kids with this awareness. We have our challenges, but relatively speaking, we're very, very blessed to help — whether it's a neighbor, whether it's a stranger. If we can help make somebody else's life just a little bit easier, especially during the holidays, we're happy to," he said.

In recent weeks, the work of nonprofits like Project Angel Food has come under scrutiny. On Nov. 21, the United States House of Representatives narrowly voted in favor of the Stop Terror-Financing and Tax Penalties on American Hostages Act, which could give the U.S. Treasury Department sweeping power to remove tax-exempt status from any organization deemed to be supportive of terror-

ism. Democratic opponents have argued that the incoming Donald J. Trump administration could use the act to go after political enemies.

"That's why we have two chambers — checks and balances to make sure that, while some members of the House may want to politicize every vote [and] politically attack organizations — more regional divides in the Senate will protect the good causes and the good uses of taxpayer funding," Padilla said.

He pointed out the long history Project Angel Food had as a powerful humanitarian force in Los Angeles, noting that the very first government grant provided by FEMA to the organization was presented by the late Sen. Dianne Feinstein (D-Calif.) in 1993.

"If we can look at the multiple ways that Project Angel Food is helping communities — whether it's addressing food insecurity ... whether it's providing medically strategic food that keeps people healthy, then we're reducing health care costs. Imagine that — bringing down health care costs in America. This is an innovative and successful way to do it. I hope my colleagues in Washington will pay attention to this program and others like it," Padilla said.

He added that if his colleagues would observe the work of Project Angel Food, they might return next week to Congress with a reminder of the purpose of public service.

"Yes, we have different ideas. We have different philosophies, maybe different priorities based on your district [and] based on the state that you represent, but at the end of the day, we're in public service to try to improve lives," Padilla said.

He said the organization's mission was in lock step with the city that raised him.

"Project Angel Food is the spirit of Los Angeles," he explained. "We're not just a big, spectacular city in America. We're from the most diverse city in America, from all aspects ... racially diverse, eco-

nomic diverse, ethnically diverse — but people come together on a daily basis, whether it's people working side by side, playing little league baseball side by side, volunteering side by side, to help our neighbors. That is the spirit of Los Angeles as I know it."

Project Angel Food will have numerous celebrities on hand Thanksgiving Day to help prepare and deliver meals, including "Weird Al" Yankovic, Jai Rodriguez, Mary McCormack, Charlie Wood, Natalie Morales, Mark McGrath and Loni Love. For information, visit [angelfood.org](http://angelfood.org).



## Beverly Hills lowers flag for rabbi

The city of Beverly Hills will lower its flag to half-staff until Saturday, Nov. 30 to mourn the loss of Israeli-Moldovan rabbi Zvi Kogan, who was brutally murdered in the United Arab Emirates last week. Mayor Lester Friedman will also call for a moment of silence at the Dec. 3 City Council meeting.

"Once again, another atrocious, heinous act has shaken

those around the world who celebrate their Jewish heritage," Friedman said. "Rabbi Zvi Kogan did not deserve to leave this Earth in such a barbaric way and we must continue to stand strong against antisemitism and hatred of all kind."

Three Uzbek nationals were arrested in connection with the kidnapping and murder of Kogan.



## A LETTER TO **The Beverly Fairfax Community**

### **To our Neighbors:**

We'd like to bring you up to date on our efforts to protect surrounding communities from the negative impacts of the proposed Television City expansion at Beverly & Fairfax.

We support a new, larger studio, and throughout two years of meetings with the developer and Councilmember Katy Yaroslavsky, we pushed for meaningful changes to balance business and community interests – addressing traffic problems, cutting excess office space, tightening the construction period, and reining in the zoning. Despite valid public concerns, the City Planning Commission approved the developer's proposal to expand Television City without those changes.

**On December 3 at 2PM, we get another chance to push back against this massive overdevelopment at a hearing held by the City Council's Planning and Land Use Management (PLUM) Committee. The meeting will be held at City Hall, Room 340.**

The proposed development will be twice the size of the Beverly Center, and 85% of the increase is office space, not studio operations.

- It will cause massive gridlock and cut-through traffic and impact response times from emergency vehicles.
- The developer plans on a 20-year construction timeline, bringing decades of disruption to surrounding communities.
- Permissive new zoning that can open the door to future reckless development.

Despite an acute housing shortage, this project includes not one unit of housing – in fact, it will likely drive up rents and displace current residents in our neighborhood's rental units.

These are just some of the reasons that more than 2,200 local residents signed petitions against the project, more than 450 residents, community organizations and local businesses submitted letters opposing the project, and 9 community organizations and local businesses submitted official appeals.

When Councilmember Katy Yaroslavsky took office, she said the project needed "a big haircut." Now, after the developer gave it a tiny trim, Councilmember Yaroslavsky supports it.

## Norms may be replaced by Raising Cane's

■ Diner's lease ends in late 2026, paving way for chicken chain

Norms, a 1950s-era diner that has been a longtime fixture on La Cienega Boulevard, may become a Raising Cane's fast food restaurant in 2027. The 24-hour breakfast restaurant's lease is set to expire in late 2026, at which point Raising Cane's – the current landlord – plans to turn it into one of its many locations serving fried chicken fingers. The proposed rehabilitation

will be presented to the city of Los Angeles Cultural Heritage Commission on Dec. 5.

"Norm's has an existing lease at its La Cienega location until December 2026. After that time, Raising Cane's plans to keep the legacy of Norm's alive and maintain – forever – the iconic Googie-style architecture made famous by Armé and Davis when we begin improvements to restore the property and serve craveable chicken finger meals to the L.A. community," a Raising Cane's spokesperson said. "The building has been designated as a historic-cultural monument and that designation requires

preservation of the building, inside and out, including the iconic pennant-style sawtooth sign and diner-style seating. Our goal is to continue working with the Cultural Heritage Commission to ensure that legacy of Norms is preserved for future generations in the community."

A rendering provided by Raising Cane's shows the planned rehabilitation, with the restaurant maintaining a similar exterior appearance to its current state. The most notable difference is the large orange letters on the eponymous Norms sign have been replaced to read Cane's, with an apostrophe affixed to the E.

Norms, a Southern California diner chain, is known for its Googie architecture – a quirky mid-20th century futurist movement that was developed in Southern California. The architecture style features angular roofs, boomerang-like shapes and neon lights that harken back to the dawn of the Space Age.

The restaurant at 470-478 N. La Cienega is the oldest surviving Norms location, first opening its doors in 1957. In 2015, the location became a Los Angeles historic-cultural monument, a move that prevented it from being demolished following a campaign by the Los Angeles Conservancy to save the building.

According to its website, there are 23 Norms locations in the Los Angeles area and one in Las Vegas.

Bobby Green – a designer and business owner whose company the 1933 Group has preserved and

reopened several historic L.A. eateries, including Tail O' the Pup and the Formosa Café – said he was "confusingly shocked" when he heard about the plans for the Norms on La Cienega Boulevard.

"I knew what a struggle and fight that the Norms building was to save," Green said. "Once something like that is designated as a cultural landmark everyone kind of breathes a sigh of relief and moves onto the next battle. But in this case, it's very interesting because you're dealing with a legacy busi-

ness now, not a legacy building ... I don't think anyone in the preservation groups of L.A. have really encountered a situation like that."

Green said he hopes Raising Cane's will see the value in keeping Norms in its original building.

"To go into a space like that and not get diner food would just feel so weird," Green said.

Raising Cane's will present its plan to the Cultural Heritage Commission on Dec. 5 at 10 a.m. in Room 1010 of Los Angeles City Hall, 200 N. Spring St.





## Robbery crew targets victims on Rodeo Drive

■ Suspects steal handbags during brazen hold-up

Beverly Hills Police Department investigators are searching for four male suspects who robbed two victims around 1:20 p.m. on Nov. 23 in the 400 block of North Rodeo Drive.

The victims, one male and the other female, were standing on the sidewalk when they were approached by four suspects. One suspect brandished a firearm and a physical altercation occurred involving both victims and the suspects, police said.

The robbery was captured on video and first broadcast on social media by Street People of Beverly Hills, and later widely broadcast by television news outlets. In the video, the suspects can be seen scuffling with a victim who is

lying on the ground as the female victim is close by. The assailants are then seen running away west on Brighton Way.

The robbery occurred on the sidewalk near the BVLGARI, Maison Goyard and Cartier stores. Police said the suspects stole two designer handbags containing cash and cell phones. One cell phone was recovered near the scene. The suspects also attempted to steal the male victim's jewelry but were unsuccessful, police said.

Beverly Hills Fire Department paramedics examined both victims, who sought their own medical attention. The investigation is ongoing and the BHPD is attempting to identify the suspects, Lt. Andrew Myers said.

## Leads sought in shooting that injured woman in Hollywood

Police are searching for a gunman who shot and injured a woman in Hollywood in mid-October and are asking for the public's help to identify the suspect. Investigators released photographs of the assailant, who is described as Hispanic, 20-25 years old, 5 feet 5 five inches tall and 130-160 pounds.

The shooting occurred on Oct. 15 at approximately 12:15 p.m. on Hollywood Boulevard near Western Avenue. The female victim was in the process of renting an e-scooter when the suspect approached her and the two became involved in argument, police said. The suspect pulled

out a handgun and fired several times at the woman before fleeing south on Western Avenue.

Police said the victim was struck by the gunfire and sustained "non-life-threatening" injuries. She was treated at a hospital and released.

A witness took photographs of the assailant as he was fleeing. After exhausting all leads, investigators released the images to the public on Nov. 21. ## Menendez resentencing hearing rescheduled

■ Brothers' aunts give emotional testimony during court appearance

A Nov. 25 status hearing in the Menendez brothers case resulted in the rescheduling of a resentencing hearing from Dec. 11 to Jan. 30. The November hearing, although mostly procedural, included emotional testimony from two relatives advocating for the release of the brothers, Erik and Lyle Menendez.

"I'm not ready to go forward," Judge Michael V. Jesic said at the hearing, stating that he had "17 boxes" of documents to go through before he could make any decisions related to the case. Additionally, he said that he would be pushing the hearing to give the new Los Angeles County District Attorney Nathan Hochman time to review the case as well as new evidence. Hochman will be sworn in as district attorney on Dec. 2.

The brothers were sentenced to life in prison without the possibility of parole in 1996 for the double murder of their parents, Jose and Kitty Menendez. The high-profile murder took place in the family home in Beverly Hills in 1989. While the determination that the brothers murdered their parents has not been contested, new evidence has since come to light that the district attorney's office said could affect the sentencing of the brothers. Calls for their release have also grown louder due to increased attention from a recent Netflix series and documentary.

Incumbent district attorney George Gascón, who was defeated by Hochman in the Nov. 5 election, recommended the brothers be resentenced after reviewing evidence that suggests the brothers were sexually abused by their father. Gascón also supported a

clemency request for the Menendez brothers. According to the California Constitution, the governor has the authority to grant clemency in the form of a sentence commutation or pardon. Gov. Gavin Newsom recently announced he would not make a clemency decision until Hochman reviews the case.

The brothers were scheduled to appear virtually in the Nov. 25 hearing, but due to technical difficulties they were not visible to the courtroom. Two of their aunts – Jose Menendez's sister Terry Baralt and Kitty Menendez's sister Joan VanderMolen – were present in court to ask that the judge release Erik and Lyle.

The 85-year-old Baralt – who flew from New Jersey for the hearing – pointed toward the brothers' behavior in prison, stating that they have done "a lot of good things" while incarcerated.

"I would like to be able to hug them and see them ... not in a jail," she added.

She described her sister-in-law

Kitty Menendez as her "best friend," and that while she misses Jose and Kitty, she believes the brothers have successfully rehabilitated and done enough time behind bars.

"We miss those that are gone tremendously. But we miss the kids too," Baralt said. "I know they're not kids anymore. To me they are."

VanderMolen, who turned 93 on Nov. 26, argued that the brothers should be released based on the alleged repeated abuse committed by Jose Menendez.

"No child should have to endure what Erik and Lyle went through at the hands of their father," VanderMolen said in court. "It breaks my heart that my sister Kitty knew and did nothing about it."

Following the hearing, the brothers' attorney Mark Geragos applauded the aunts' testimony and looked ahead to the next hearing.

"By Jan. 30 or 31 – we're hoping that by the end of that or sometime sooner – we will in fact get the brothers released," Geragos said.

## D.A. files charges against B.H. carjacking suspect

Los Angeles County District Attorney George Gascón has filed carjacking and hit-and-run charges against 22-year-old James Portul, who is accused of stealing a car and crashing into four pedestrians in Beverly Hills on Nov. 14 before running from the scene.

According to the Beverly Hills Police Department, officers received a call reporting a carjacking in the 400 block of North Bedford Drive at approximately 7:06 p.m. on Nov. 14. Portul allegedly used force to steal a black BMW X3 from a woman and then fled in the vehicle, police said. Shortly after, Portul lost control of the vehicle and crashed into four pedestrians near the intersection of Wilshire Boulevard and Camden Drive before fleeing on foot. According to the BHPD, officers quickly detained Portul in the 200 block of South Beverly Drive.

The chaotic incident took place

near the "Rodeo Nights, Holiday Lights" event, where families gathered to celebrate the holiday season.

Russell Stuart, a local business owner who was recently elected to the Beverly Hills Unified School District Board of Education, was buying a balloon for his daughter near the event when he was suddenly struck by the vehicle. Stuart, who was hospitalized with critical injuries, was discharged on Nov. 23.

On Nov. 26, Stuart said he is still recovering at home "slowly, but in the right direction."

"I'm very pleased to hear that Mr. Gascón's office has chosen to press charges against this gentleman and move forward with the prosecution," Stuart said. "I've been very displeased with Mr. Gascón's performance as our D.A. for a very long time, but that was obviously as a third-party bystander. Now that I'm a victim of violent crime myself I see things in a harsher light. To know that although Mr. Gascón will be leav-

ing [office] on Dec. 2 ... I'm very pleased to hear that charges have been filed."

He said he hopes the suspect is held accountable to the fullest extent of the law, and that the charges send a message to deter violent crime in Los Angeles County.

The D.A.'s office said Portul pleaded not guilty during his arraignment. A preliminary hearing is scheduled for Dec. 5.

Stuart added that the support he has received from the community following his injuries has been "absolutely overwhelming," as he has received well wishes from current and former City Council members, school board members and many Beverly Hills residents whom he did not know prior to the incident.

"It's a testament to why we live here. Beverly Hills is not a city, it's a community," Stuart said. "I could've never imagined [the support]. It's really given me more strength to heal faster."

## Authorities warn about dangers of impaired driving

Law enforcement officials are taking a zero-tolerance approach to driving under the influence during the Thanksgiving holiday weekend.

The California Highway Patrol is activating its Thanksgiving Maximum Enforcement Period

through Sunday. The Beverly Hills Police Department, Los Angeles Police Department and Los Angeles County Sheriff's Department are also stepping up patrols and DUI enforcement.

Members of the public are

warned about the dangers of driving while under the influence of alcohol and drugs. Always designate a driver. Motorists are reminded that impaired driving can also be caused by marijuana and prescription drugs.

## Metro holds Beverly Hills meeting on subway work

The Los Angeles County Metropolitan Transportation Authority is holding a meeting on D Line subway construction on Wednesday, Dec. 4, at 6 p.m. in the Municipal Gallery at Beverly Hills City Hall, 455 N. Rexford Drive. The meeting will focus on work in sections one and two of the project from Wilshire/Western to Century City/Constellation. For information, visit metro.net.

Street restoration work is ongoing at many locations along the route. Near Wilshire/Western,

street restoration is expected to continue through January. Wilshire Boulevard is reduced to two lanes in each direction between Oxford Avenue and St. Andrews Place. Left turns are prohibited from Wilshire Boulevard to Western Avenue and from eastbound Wilshire Boulevard to northbound St. Andrews Place. The temporary traffic plan supports street restoration work near the Wilshire/Western construction yard.

Through March 2025, a K-rail work zone is located in the middle of Wilshire Boulevard between Courtyard Place and Masselin Avenue to support construction in the tunnels below Wilshire Boulevard. Wilshire Boulevard is reduced to two lanes in each direction between Ridgely Drive and Curson Avenue, and left turns are prohibited along Wilshire Boulevard in the area.

Work is also occurring on Wilshire Boulevard near Fairfax Avenue. Through March, Wilshire Boulevard will be reduced to two lanes in each direction at La Jolla Avenue. A K-rail enclosure is located on the west side of the Wilshire/La Jolla intersection to accommodate work in a cross passage between the tunnels.

At the Wilshire/La Cienega station, crews are working the construction staging areas and at street level along the north side of Wilshire Boulevard between San Vicente and La Cienega boulevards. ### Summary of Ordinance No. 24-O-2903

This is a summary of the above entitled ordinance of the City of Beverly Hills. This summary has been prepared and published in accordance with the requirements of Government Code Section 36933.

The ordinance is intended to support the production of Accessory Dwelling Units (ADUs) as part of Implementation Program 10.4 of the City's 2021 - 2029 Housing Element. The ordinance introduces the following changes to the Beverly Hills Municipal Code (BHMC) to facilitate ADU construction, expand housing options, and increase the availability of rental units within Beverly Hills:

- Greater flexibility for multi-family ADU development standards, including:
  - Increases in allowable height and floor area;
  - Reductions in rear and side setbacks for properties abutting alleys;
  - Allowance of internal-facing balconies; and
  - Establishment of a new discretionary process allowing deviations from development standards.
- Authorization of an additional ADU that is consistent with minimum state law

standards on single-family properties with a lot area of 13,000 square feet or greater, with at least one ADU deed-restricted as a rental unit.

### ENVIRONMENTAL REVIEW

The City Council determined that this ordinance is within the scope of and consistent with the Addendum to the Mitigated Negative Declaration for the Amendments to the Adopted 2021- 2029 City of Beverly Hills Housing Element (State Clearinghouse No. 2021090102), which was adopted by the City Council on March 18, 2024 and certified by the State Department of Housing and Community Development on May 1, 2024. Furthermore, the ordinance is statutorily exempt from CEQA pursuant to §21080.17 of the California Public Resources Code. This section specifies that the adoption of an ordinance regarding ADUs to implement the provisions of Government Code §§65852.1 or Article 2 (commencing with §66314) of Chapter 13 of Division 1 of Title 7 of the Government Code is exempt from CEQA requirements.

The Ordinance was unanimously approved and adopted on November 19, 2024, effective December 20, 2024. Those voting for or against adoption of Ordinance No. 24-O-2903 are as follows:

### Situation involving BHHS teacher deserves more scrutiny

Re "BHHS teacher says she was fired after criticizing Trump," Nov. 21 issue

I was very disturbed by an article appearing in the Nov. 21 issue of the Beverly Press concerning the termination of Joanie Garratt by the Beverly Hills Unified School District.

Based on the article, it appears that Ms. Garratt was terminated by the BHUSD as a result of her Facebook post of Nov. 7, reacting to what was to all accounts (in the Beverly Press and other media) a problematic incident at Beverly High following the recent election. The Beverly Press article notes that a BHUSD representative "would not confirm or deny Garratt's termination."

Ms. Garratt's apparent termination raises a number of questions which I, as a long-term Beverly Hills resident, would like to have answered by the BHUSD. I have written to the members of the Beverly Hills Board of Education about my concerns.

My questions include the following: Was Ms. Garratt in fact terminated, or is she currently employed by BHUSD in her capacity as "a substitute teacher on a long-term assignment?"

If Ms. Garratt was terminated, what were the grounds for such termination?

Was such termination in any way connected, as she asserts, with her Facebook post?

If her termination was connected with her Facebook post: did Ms. Garratt utilize any property of BHUSD (such as a computer, iPad, cellphone, etc.) in making the post?

Was the Facebook account on which the post was made her personal Facebook account or a BHUSD Facebook account?

In her post, did Ms. Garratt purport to be speaking on behalf of the BHUSD, or was she only reporting her reaction to the events?

Does the BHUSD have a written policy setting forth limitations on what a staff member may post on his/her personal social media accounts? If so, what is the policy, and how is it disseminated to staff members?

If there is a policy, what is the practice of the BHUSD in situations where there has been an alleged violation?

Do people get warnings, or is such a violation always a ground for termination?

What kind of "due process" is followed in such situations?

I do not know Ms. Garratt, and I have no knowledge concerning her employment history, reputation, etc. with BHUSD. I would have asked the BHUSD the same questions if, for example, another faculty member in similar circumstances had been terminated after expressing satisfaction over the outcome of the recent election.

Either case raises serious potential freedom of expression issues.

Apart from the First Amendment issues, I have very practical concerns. In my almost 50 years as a Beverly Hills resident, I have seen numerous examples of city authorities (city, police department, BHUSD, et al) taking employment and other actions, getting sued for them, and ultimately losing the resulting litigation or entering into expensive settlements after expending lots of money in defense. I am concerned that if Ms. Garratt has in fact been unfairly treated and chooses to take legal action, we will see a similar playbook.

I am also concerned that if the policies of the BHUSD are not properly communicated (or are otherwise opaque) or are not consistently applied, we will have similar results in future situations. Broad policy issues are also raised over how the BHUSD reacts to this kind of circumstance, and what can be done to improve its practices to avoid the potential for claims.

If the Beverly Press and other media accounts are at all accurate, this is a significant embarrassment to the city of Beverly Hills, the

BHUSD and to those residents of Beverly Hills who love and would like to remain proud of their very special city.

## L.A. County launches Office of Food Equity

A partnership formed by the county of Los Angeles and Los Angeles philanthropic organizations has announced the formation of the Los Angeles County Office of Food Equity. The L.A. County Board of Supervisors unanimously supported the creation of the initiative, which aims to address the root

causes of food-system problems in the region.

The partnership also announced that Paula Daniels – who previously served as senior advisor on food policy to former L.A. Mayor Antonio Villaraigosa and founder of the L.A. Food Policy Council – will be leading the L.A. County

Office of Food Equity. The initiative is being incubated as a public-private partnership among the county of Los Angeles, the Annenberg Foundation, the California Community Foundation and the Weingart Foundation.

Daniels will work to expand the countywide commitment to food system goals and advance implementation of key priorities in the multi-pronged Action Plan developed by the Los Angeles County Food Equity Roundtable, a stakeholder advisory group of diverse experts from various sectors of the food system. The county's Emergency Food Security Branch and the three foundations created the roundtable in 2021. Nearly 200 thought leaders from various sectors engaged in the initiative, all focused on fundamentally transforming the region's disconnected food system.

This multi-sector effort began in response to the global pandemic, when tons of food from the supply chain went to waste and many farmers faced financial crisis even as vulnerable populations sought greater access to health and nutritious food.

According to a USC report, one in three households – 34% – in L.A. County experienced food insecurity during the pandemic, and the number still hovers at around 30% today. Yet, the county is home to more than 1,000 farms and sits adjacent to Southern and Central California counties that are the country's largest producers of fruits,

nuts and vegetables.

"The county has a responsibility to act as a safety net for our most vulnerable communities, who disproportionately suffer from food insecurity," said L.A. County Supervisor Janice Hahn, 4th District, who helped create the Food Equity Roundtable. "This new Office of Food Equity marks an important first

World AIDS Day is an opportunity for people worldwide to unite in the fight against HIV/AIDS, to show support for people living with HIV, and to commemorate people who have passed away due to HIV/AIDS. Annually, UNAIDS agencies, governments, nonprofit organizations, community groups and others around the globe join to campaign around specific themes related to AIDS. This year, communities will commemorate #WorldAIDS Day under the theme

"Take the rights path: My health, my right!" and the World Health Organization is calling on leaders and citizens to champion the right to health by addressing the inequalities that hinder progress in ending AIDS.

West Hollywood will recognize World AIDS Day 2024 with events and programming.

A panel of the AIDS Memorial Quilt will be on display in the West Hollywood's Council Chambers/Public Meeting Room, located at 625 N. San Vicente Blvd. from Nov. 25-Dec. 20 courtesy of the National AIDS Memorial. Considered the largest community arts project in history,

the AIDS Memorial Quilt helps the global community remember the unique lives and stories of those we've lost to HIV/AIDS. The quilt was conceived in November 1985 by long-time human rights activist, author and lecturer Cleve Jones with the goal of creating a memorial for those who had died of AIDS, and to thereby help people understand the devastating impact of the disease. The first meeting of devoted friends and lovers of some of the nearly 1,000 San Franciscans who had been lost to AIDS by the mid-1980s served as the foundation of the NAMES Project AIDS Memorial Quilt. Today, there are roughly 50,000 panels dedicated to more than 110,000 individuals in this epic 54-ton tapestry.

The Alliance for Housing & Healing, a program of APLA Health, will lay flowers on the bronze plaques embedded in the sidewalk along the West Hollywood AIDS Memorial Walk on Santa Monica Boulevard from Crescent Heights Boulevard to N. Robertson Boulevard. West Hollywood was one of the first government entities to provide social services grants to local AIDS and HIV organizations and, throughout its history, the city has directed millions of dollars to fund HIV/AIDS direct services, education, and public awareness efforts. The West Hollywood Memorial Walk was created in 1993 to honor

people who were lost to the AIDS pandemic, with new plaques being added regularly.

West Hollywood will join STORIES: The AIDS Monument and APLA Health in a World AIDS Day event on Sunday, Dec. 1. The event will begin at 2 p.m. with a reception at the West Hollywood Park Aquatic and Recreation Center Respite Deck, located at 8750 El Tovar Place, adjacent to West Hollywood Library. RSVP is requested via eventbrite.com/e/world-aids-day-in-west-hollywood-tickets.

Following this, the Lavender Effect will host the Young City at War Exhibit Launch and Reception at 3:30 p.m. The exhibit will be featured under the Grand Staircase at West Hollywood Park. Young City at War: Stories from West Hollywood During the AIDS Epidemic will feature the dramatic and poignant story of a diverse community's response to the early days of the HIV/AIDS epidemic. This public installation honors the warriors of the past and present, as well as showcases the power of community. It celebrates the leadership, strength, and endurance of the people and city of West Hollywood. It also provides awareness, inspiration and wisdom for new generations.

Events are free to attend and open to the public. Limited parking will be available at the West Hollywood Park 5-Story structure.

## Authorities warn about potentially contaminated raw milk

The Los Angeles County Department of Public Health is warning residents to avoid consuming raw milk that has been recalled by The Raw Farm due to a detection of H5 bird flu virus in a retail sample. Many retailers in Los Angeles may have sold the recalled raw milk and health officials are warning the public.

The Raw Farm, LLC issued a vol-

untary recall, at the request of the state, of cream top whole raw milk with lot code 20241109 and a "Best By" date of 11/27/2024 printed on the packaging. Customers should immediately return any remaining product to the retail point of purchase. Retailers that sold the milk in the local area include Erewhon Market, including the store at 7660 Beverly Blvd.; Eataly, 10250 Santa

Monica Blvd.; and Lazy Acres, 1841 N. Western Ave., at Los Feliz Boulevard, according to the Los Angeles County Department of Public Health. Additional retailers may be confirmed as the investigation continues.

No illnesses associated with the lot of raw milk have been reported in L.A. County. Out of an abundance of caution, and due to the

ongoing spread of H5 bird flu in dairy cows, poultry and sporadic human cases, consumers should not consume any of the affected raw milk. The California Department of Public Health is also notifying retailers to remove the affected raw milk from shelves. L.A. County health inspectors are visiting retail establishments where the product was sold to ensure it is no longer available for purchase.

Raw milk is milk that has not been pasteurized to kill harmful bacteria.

Raw milk – and products made from it such as queso fresco – can carry harmful germs such as listeria, salmonella, Campylobacter, E. coli, viruses and parasites. The germs can present serious health risks.

Anyone who has consumed the raw milk and is experiencing flu symptoms should immediately contact a health care provider. For information, call the Public Health Infoline at (833)540-0473, or visit ph.lacounty.gov/acd/diseases/h5n1.htm.

## County makes fentanyl test strips available at West Hollywood Library

To combat the ongoing opioid overdose crisis and support harm reduction strategies, Los Angeles County Library is expanding naloxone clinics, including a site at the West Hollywood Library, to offer free fentanyl test strips.

The initiative, in partnership with the California Department of Health Care Service, aims to create

safer and healthier communities by providing resources to help mitigate risks associated with opioid use.

"Fentanyl poisonings are not something we can bury our heads in the sand on. Our young people are at risk, and parents are scared. Bringing these life-saving tools like test strips and naloxone into libraries and making them as accessible as

possible to every community makes sense," said Supervisor Janice Hahn, 4th District, who led the board of supervisors in establishing the naloxone clinics at county libraries. "I'm thankful to our L.A. County library staff for their willingness to be this critical resource for the communities they serve."

Fentanyl test strips are available the West Hollywood Library every Wednesday from noon-4 p.m. Twelve other county library branches will also provide the strips including the A.C. Bilbrew Library, Claremont Helen Renwick Library, Compton Library, East Los Angeles Library, El Monte Library, Lancaster Library, Leland R. Weaver Library, Lennox Library,

Malibu Library, Norwalk Library, San Fernando Library and Temple City Library.

"L.A. County Library is committed to supporting the health and well-being of our communities," L.A. County Librarian and CEO Skye Patrick said. "By offering

both naloxone and fentanyl test strips, we are taking proactive steps to reduce the devastating impact of the opioid crisis in Los Angeles County."

Fentanyl is a synthetic opioid up to 50 times stronger than heroin and 100 times more potent than morphine. It is often mixed into other substances without individuals being aware, making it extremely dangerous. Even a tiny amount can be fatal. Fentanyl test strips detect the presence of fentanyl, helping prevent accidental exposure and reducing the risk of fatal overdoses.



## Landmarks lit in red on World AIDS Day renew commitment to end HIV

The Los Angeles County Department of Public Health will observe the 36th annual World AIDS Day on Sunday, Dec. 1. To commemorate this year's theme "Collective Action: Sustain and Accelerate HIV Progress," the department is illuminating landmarks throughout the county in red on World AIDS Day.

The goal is to honor those impacted by HIV/AIDS, renew a collective commitment to ending the epidemic and provide optimism for the future. The illumination of landmarks demonstrates unity and provides a visual reminder of the county's collective action in combatting the disease.

The landmarks include the Petersen Automotive Museum, Paramount Pictures' Studio Water Tower, Los Angeles Union Station, the Rose Bowl, the Los Angeles Department of Water and Power's John Ferraro Building, the Ritz-Carlton Los Angeles, the Long Beach Convention Center, the Queen Mary and the Aquarium of the Pacific.





## L.A. Jazz Society opens mentorship program applications

The Los Angeles Jazz Society announced that applications for the Bill Green Mentorship Program are now available for 2025. Students within the public school system – mostly high school age, up to 18 – are encouraged to apply for the eight-week program that includes music lessons from professional musicians.

Named in the memory of the great multi-woodwind instrumentalist and jazz educator, Bill Green, the mentorship program was initiated in 1988 to supplement the education of promising young jazz students and to encourage their development as future professional jazz artists. 2025 will also celebrate what would have been Bill Green's 100th birthday. Each year, approximately 25 students are chosen from

those applying. Lessons are scheduled with individual mentors in their chosen instrument field, including Ira Nepus, Scott Whitfield, Richard Simon and Stuart Elster. Students and mentors subsequently combine to rehearse in a jazz band format and perform in a jazz concert at Catalina Jazz Club.

The application deadline is Jan. 17 and auditions are scheduled for Jan. 25. Questions regarding applications can be directed to info@lajazz.org or to the program director iranepus@aol.com.

The Bill Green Mentorship Program boasts an impressive roster of almost 500 graduates to date, many of whom have gone on to future study, and many of whom are successful performing musicians.

The Los Angeles Jazz Society was founded in 1983, initially to honor Los Angeles Jazz artists for their contributions to jazz. Its purpose was and is to promote, preserve and perpetuate the American art form, jazz. Recognizing that the future of jazz rests in the hands of young musicians and jazz lovers, the L.A. Jazz Society quickly developed and expanded its jazz education programs which now benefit thousands of young people in LAUSD schools each year. Programs include Jazz in Schools – free jazz education concerts in elementary schools for 25,000 students; the Bill Green Mentorship Program – free training in advanced musical techniques from professional musicians for young aspiring jazz musicians; and the

## 'Wicked' defies the moment

When the movie "Wicked" was in production, its cast and crew could not have known the environment in which it would land in the theaters. Certainly, in 2003's fresh wave of "United We Stand" patriotism, composer Stephen Schwartz couldn't have heard how his new stage show might play two decades later. Nor in the economic boom of the mid-1990s, when the Gregory Maguire book was released, could the author have imagined how his Wicked Witch tale would resonate 30 years into the future.

And yet, here we are, with a box office juggernaut born from a story of a woman of color defying a man

who crafts a dangerous lie to oppress an entire subset of a population. Chilling, isn't it? And being that "Wicked" is anything but subtle, it would seem almost impossible to miss the analogy. However, I'd bet a good half of the population will. The obvious, after all, is so often missed by the masses.

We all know "The Wizard of Oz." Even those that miraculously missed the movie have seen it referenced, ad nauseum. "There's no place like home." "Follow the yellow brick road." "I'll get you my pretty, and your little dog, too."

Based on the 1900 novel by L. Frank Baum "The Wonderful Wizard of Oz," the iconic 1939 film is so enshrined in pop culture that,

though Baum wrote many sequels to his book, additional Oz screen adaptations have struggled to find their footing. 1978's "The Wiz" is inferior to its Broadway predecessor. 1985's "Return to Oz" is barely remembered. 2013's "Oz the Great and Powerful" was maligned by critics. But the book and subsequent musical "Wicked" did the seemingly impossible. It honored the original story and the celebrated Technicolor classic, all while creating something entirely unique in and of itself. Certainly, to understand "Wicked," cursory knowledge of "The Wizard of Oz" is a necessity. But if you don't know that one, I'll direct you to Wikipedia.

"Wicked" is the backstory of Elphaba (Cynthia Erivo), destined to be the Wicked Witch of the West, and Galinda (Ariana Grande), later to become Glinda the Good Witch of the North. In their youth, they are simply roommates at Shiz, the sorcery university of record in Oz. Though they initially loathe one another, the two eventually form an unlikely friendship. Elphaba, born with green skin and different from all her fellow students, is concerned about Oz's animal residents – once treated as equals to humans, but now increasingly muzzled and caged. She thinks taking her worries to the Wizard (Jeff Goldblum) could help fix the animals' marginalization, but when Elphaba makes



her way to Oz, she discovers all that's emerald does not glitter.

That's the baseline, but there's a lot more going on. "Wicked" clocks in at two hours and 40 minutes, after all, which is almost as long as the stage show – and this is just part one! The second half of the story is expected to hit theaters next November. Fans of the stage show are likely to rejoice at the expanded beats, with increased time devoted to Elphaba's childhood and the show's entertaining side characters. There's even a few new Ozians and additional verses added to the popular showtunes, including a cameo-laden "One Short Day." For those unfamiliar, the pace is such that the length is not overly felt – yes, the movie is longwinded, but its energy and opulence never bore.

The character work by Erivo and Grande is awards-worthy, with Grande easily entering the Oscar race as the Supporting Actress frontrunner. Jonathan Bailey plays the love interest Fiyero and proves in his first frame that he should be leading every possible romantic comedy in perpetuity. He's as if Hugh Grant and Cary Grant had a love child, except even more charming and he can dance, so somehow he's also a mold of Hugh Jackman and Gene Kelly.

In many ways, "Wicked" is a testament to old-fashioned filmmaking. While CGI is utilized to fill in some frames and animate the talking animals, practical effects and humongous sets were deployed for this \$150 million production, and it is a constant feast for the eyes (and ears). It looks expensive, and while not quite as saturated as the Oz of Judy Garland, the pops of pink and, especially, green are doled out to effectively punctuate some of the

most impactful numbers. In fact, as "Wicked" progresses, the color grading seems to get more saturated, more contrasted, darker. Whereas the skies are a near-cloudless light blue at the start, a stark crimson provides the backdrop of the Earth-shattering "Defying Gravity" closer – leaving the audience with a sense of foreboding wonder. The film literally loses its innocence as it progresses.

Elphaba's disillusionment is the realization that the world is not what it seemed. While it is the hope that the strength can be summoned to "look toward the Western sky" and grab a broomstick, the appropriate rally song to accompany America's current plight seems less assured.

The message of "Wicked" has been around for decades, but while some seemed to have gotten it after the first read, the first listen to the cast album or the first time seeing the show, others will – again – walk away from the film without the parallels so much as registering. I implore any viewer to imagine the world through another's skin, and to take this openness with them through the movie.

The uncertainty of the future – perhaps the only certainty of life – requires a relentless optimism, even in the face of doom. When Erivo conjures up her full force, casting her expansive cape as an imposing shadow across Oz, the willpower absent for so many warriors – weary from a decade of sign-making and marching – is conjured anew.

"Wicked" may not have been made with the knowledge it would be released in the current global environment, but it certainly meets the moment.

## New exhibits take shape at Marciano Art Foundation

Marciano Art Foundation has announced advance details of new exhibitions and programming opening in late 2024 and continuing through early next year.

A prominent highlight will be Doug Aitken's ambitious "Lightscape" installation, opening Dec. 17. "Lightscape" builds upon Aitken's practice of creating larger-than-life, multisensory artworks that address interconnectedness through depictions of Southern California and the American West. Presented in partnership with the LA Philharmonic and LA Master Chorale, the seven-channel installation will prominently feature a soundscape of original vocal pieces by iconic minimalists such as Philip Glass, Meredith Monk and Steve Reich, alongside ambient soundscapes composed for the film by Doug Aitken and Beck.

Weekly programming tied to "Lightscape" will feature special

performances from members of the LA Philharmonic, LA Master Chorale, and other artists each Saturday afternoon at the foundation through the run of the installation.

More information on the full lineup of programming will be announced in the coming weeks, with ticketing details available soon.

MAF will also inaugurate a new gathering space with an installation by artists Kristen Wentreek and Andrew Zebulon entitled "Quaternion," also on Dec. 17. This first project in the Marciano Library is presented in collaboration with Los Angeles art and design gallery Marta, and will draw on the materials, textures, and palette of Millard Sheets' Scottish Rite Masonic Temple.

Situated on the foundation's ground-floor, "Quaternion" will present sculptural furniture works

as a tight nodal ensemble that responds to the building's ornamental details like mosaic, stained glass, and carpeting. Wentreek and Zebulon's gestures for seating and tables merge global allusions with the historic and contemporary idiosyncrasies of MAF's architecture as seen through its angles, orientations, and philosophies of space. The exhibition will offer visitors an opportunity to engage with these works directly and contemplate the design philosophies that have shaped the building and its uses for over half a century.

Moving forward, Marciano Library will be used as a gathering space for all kinds of public programs to be announced in the new year.

"Transmissions: Selections from the Marciano Art Collection" will continue to be on view across the Third Floor starting Feb. 22. Curated by Douglas Fogle and Hanneke Skerath, the exhibition

brings together over fifty international artists from the MAF collection who push the boundaries of a wide range of media in order to question what art can be, challenging the structures of both art and society at large.

Kim is a finalist for the Dayton Literary Peace Prize. She earned a bachelor's degree in art and archaeology from Princeton University.





## No awards for 'Gladiator II,' but it ain't dull

Do we need a "Gladiator" sequel? Absolutely not. The 2000 Oscar darling was a closed circuit without any hint of ambiguity by the final fade to black. Then again, any story that finds hope in the Roman Empire's liberation from monarchy should perhaps compare historical fiction to history.

"Gladiator II" often feels like it plagiarized its predecessor's blocking. Following a dramatic opening battle, our hero Hanno (Paul

Mescal) loses everything. We even enjoy a glimpse of the afterlife (no spoilers of what it is), quite similar to those wheat fields in the first "Gladiator."

Then Hanno finds a second life in the gladiator pits. Macrinus (Denzel Washington) notices the rage in him. Soon it's off to the Colosseum to celebrate another victory for Rome and the Emperor brothers, Geta (Joseph Quinn) and Caracalla (Fred Hechinger).



Meanwhile, new faces like General Acacius (Pedro Pascal) and familiar ones like Lucilla (Connie Nielsen) hope to continue the good work that began when a tyrant previously tried to snuff out any opposition to his reign. Slowly, events in the arena and backrooms converge in a historical epic tied together by one hell of a coincidence.

Just because a film need not exist. Just because it mirrors the original a bit too much. And just because that first hour is a bit of a slog, doesn't mean enjoyment is beyond scope. Any Ridley Scott film, imperfect as many contemporary contributions may be, can still deliver solid performances, grand set pieces, thrilling action and a solid story.

But several story problems will likely remove this one from critical consideration in the coming months. Beyond production quality, it's all too familiar, the kind of repetition sequels rightly are condemned for. And in this story, what are the chances that another gladiator with a unique past would emerge as an important figure in transforming Rome into a democracy?

This might be a hot take, but "Star Wars: The Last Jedi" had a wonderful response to Hollywood's love of coincidence: Perhaps we don't need it. Without spoiling anything, "Gladiator II" should have

followed that path. Instead, it pushes suspension of belief to the edge. The effect might be chilling for fans of the original film. And general spectators might be too distracted by rhinos and sharks populating the Colosseum to notice, but subsequent viewings will prove this one's undoing.

Still, some performances shine through. Ignore the haters surrounding Washington's casting. He brings his usual high dose of charm to his role as a stable master. He schmoozes the powerful while he plans their demise. Quinn and Hechinger are menacing figures in their own rite, but any comparison to Joaquin Phoenix's Commodus serves as one of many ways the sequel doesn't compare.

The driving force, beyond some heavy nostalgia, is Paul Mescal's performance. Don't compare him

to Russell Crowe. Mescal does his own thing. His character broods and clings tight to revenge. Recall that iconic line, "What we do in life echoes in eternity." Embrace it, remember how often it was displayed in classrooms or gyms. Now know "Gladiator II" includes no such original words of wisdom, though an excerpt from Virgil is heavily featured.

If you let "Gladiator II" stand apart, it's an entirely competent film, albeit clunky at times, with a fun story. But it really serves no purpose other than nostalgia, and it definitely won't spike the box office alongside "Wicked" in a post-Barbenheimer event deemed "Glicked." Like other long-gestating sequels, it reminds us how good the original was. Only "Top Gun" seems to have figured out what other franchises can't.

of a showroom at 9030 Wilshire Blvd., boasting rare vehicles with six- to seven-figure price tags. Whittington and his business were the subject of the Discovery Plus reality series "Million Dollar Wheels," which documented his vehicle sales to celebrities including Kim Kardashian and Tom Holland. However, the dealership came under scrutiny when it was revealed Whittington had been operating without a business license, without paying business taxes, without a DMV license and without necessary permits from the city of Beverly Hills. The dealership's conditional use permit was ultimately denied by the Planning Commission in June. Three different auto lessors have accused Whittington of theft, alleging he illegally sold cars that he was leasing from them. Following Whittington's arrest for a fraudulent check and at least a dozen lawsuits from former clients, Wires Only was evicted by its landlord for failing to pay rent. The cars that once glimmered through the windows of the showroom on the corner of Wilshire Boulevard and Wetherly Drive have since been removed — their whereabouts unknown.

However, a new dealership,

TBTFW — an acronym seemingly borrowed from the television series "Billions" that stands for "too big to f— with" — is aiming to fill the luxury car void left by the demise of Wires Only. TBTFW is owned and operated by Zach Ersoff, under the LLC Spur Ridge Holdings. After a Beverly Press investigation revealed an apparent connection between TBTFW and Wires Only, it was disclosed that the two dealerships once shared a rental space.

"While allegations regarding RD [Whittington] do not come as a surprise to those who have dealt with him, Spur Ridge is a completely independent entity and has no association or affiliation with Wires Only or RD Whittington," Ersoff's attorney Matthew Wolf said.

According to Wolf, the two shared the rental space during an unspecified time frame "as a cost-saving mechanism."

"Spur Ridge and RD [Whittington] had no partnership or operational relations of any kind," Wolf said.

Wolf corroborated the allegations that Whittington sold vehicles that he did not own.

"Over time, Spur Ridge became aware of RD's business practices, such as instances in which RD misappropriated vehicles consigned to

him by other vehicles brokers," Wolf said. "Those business practices quickly induced Spur Ridge to seek its own space. The move was hastily made, and Spur Ridge is still seeking recognition of a conditional use permit for the 9737 Wilshire Blvd space. Pending its CUP, Spur Ridge continues to store vehicles in its new space for exhibition purposes but cannot sell cars out of the new space."

Although Wolf denied any business relationship between Ersoff and Whittington, a lawsuit filed by former Lakers point guard Spencer Dinwiddie in June named Whittington, Ersoff, Wires Only and Spur Ridge as co-defendants. Dinwiddie alleged that Wires Only reneged on a promise to help sell his Ford Mustang after he purchased a \$1.05 million Ferrari from the dealership.

According to the lawsuit, the Mustang was purchased by Dinwiddie from Wires Only, and Dinwiddie wired the purchase price of \$699,000 to Spur Ridge for the car.

Current TBTFW general manager Chadwick Hopkins is also named as a co-defendant, and the lawsuit states that he was the general manager of Wires Only at the time of the alleged deal gone awry.

In the hearing on Dec. 12, the dealership will be represented by real estate lawyer Murray D. Fischer. The project is designed by Michael Poirier of Roman James Design Build.

supervisors, I have long championed these reforms because I know how important it is to ensure that all of our county's diverse voices are reflected in government."

In addition to approving the task force, the board of supervisors also accelerated homelessness accountability and results in the city at its Nov. 26 meeting. The motion followed voters approval of Measure A, which provides a half-cent sales tax increase specifically marked for combatting homelessness. The supervisors approved a study to potentially establish a specific county department focused on solutions to the homeless crisis. Just last week, an audit of the Los Angeles Homeless Services Authority found weaknesses in the fiscal operations of the organization.

"Make no mistake — this is not an effort to point accountability away from our board of supervisors," Supervisor Kathryn Barger, 5th District, said. "I believe a county department focused on homelessness will help us create more unity of effort and will also help end a blame game. Ultimately, our board is responsible and accountable for addressing the homelessness crisis. We are the entity that must make thoughtful, informed decisions and direct resources accordingly. The forthcoming analysis will

further fuel our work and efforts to be introspective."

The county declared an emergency on homelessness just two years ago, and the board argued that centralizing funding and program oversight with this new department will create more measurable results. While she voted in favor of the motion, Supervisor Janice Hahn, 4th District, warned against potential pitfalls.

"I am open to the idea of creating a new county department if it will actually mean bringing people inside faster and more effectively addressing this humanitarian crisis," Hahn said. "What I am not interested in is replacing one bureaucracy with another or rolling back the progress we have made linking arms with the city of Los Angeles. I will continue to dig into the practical realities of what this proposal would mean for homeless service providers and the tens of thousands of people who depend on them and I look forward to seeing the report back."

The board will make an official decision on the potential department following a review of the report.

Additional implementations of Measure G, meanwhile, will continue in the years to come. The expansion of the board of supervisors from five to nine members will happen following the next census in 2030.

including grocery stores, bakeries and restaurants to provide meals. The coalition also provides food that's donated to other organizations that offer meal services and food pantries through what's known as a community exchange. Ray said it is a unique approach that emphasizes the importance of partnerships in addressing societal issues like hunger and homelessness, as well as food waste. More than 7.5 million pounds of food have been "rescued" by the coalition since 2020.

"One thing that is super unique is that we use all recovered food, so it's food that would otherwise get wasted, to make these meals," she added. "We pride ourselves on having a dignified, welcoming, respectful environment where we know everyone by name and bring them in and really break bread with them, get to know them. And we've been making meals seven days a week all year round, no days off, and it's been an amazing thing."

Ray said an important component of the Hollywood Food Coalition's mission is wellness and providing essential services to people in need. The UCLA Mobile Clinic visits the coalition's permanent site in Hollywood weekly to provide health care services. Case managers also help connect people with resources available through service providers.

Ray said the Thanksgiving Community Dinner gives the coalition an opportunity to branch out and partner with more organizations, including Television City, which is owned by Hackman Capital Partners. The food was donated by Sysco and the tradi-

tional turkey dinner with all the trimmings was prepared by Sodexo. Clothing and supplies donated by Los Angeles Football Club and Temple Emanuel of Beverly Hills were distributed at the event.

"We are so honored to partner with the Hollywood Food Coalition," said Adeena Bleich, vice president of community relations for Television City. "Unfortunately, the situation for the food insecure and unhoused in our city continues to be a pressing issue that needs to be addressed. We understand that every stakeholder needs to be a part of the solution and helping our neighbors."

The dinner was also made possible through support from Waymo, Entertainment Partners, CoStar Group, Children's Hospital Los Angeles, ThxPhil Business Management, Kaiser Permanente, Superior Grocers, Kilroy, Los Angeles County Supervisor Lindsey Horvath, 3rd District, and Los Angeles City Councilwoman Katy Yaroslavsky, 5th District. Yaroslavsky and Horvath joined West Hollywood Mayor John Erickson and West Hollywood City Councilman John Heilman to show support at the Thanksgiving Community Dinner.



The project is proposed by Hackman Capital Partners, owner of the historic studio property at Beverly Boulevard and Fairfax Avenue. The owner is planning to modernize and expand the studio to better accommodate the needs of production companies. The plan calls for 1,724,000 square feet of sound stage, production support, production office, general office and retail uses, and the retention of 264,377 square feet of existing space. The studio's historic frontage facing Beverly Boulevard will be preserved.

The Television City project is supported by the Mid-City West Neighborhood Council, Park La Brea Residents Association, Fairfax Business Association, Melrose Business Improvement District, West Third Street Business Association, L.A. Conservancy,

Holocaust Museum L.A. and Los Angeles Parks Foundation.

Opponents believe the size and scope of the project is too large and it will have negative impacts on the surrounding community, such as bringing more traffic congestion to surrounding streets. Opponents include Caruso and The Grove, the A.F. Gilmore Company and Original Farmers Market, the Broadcast Center Apartments, the Beverly Fairfax Community Alliance, Save Beverly Fairfax, Miracle Mile Residential Association, Beverly Wilshire Homes Association and Neighbors for Responsible TVC Development.

The Los Angeles City Planning Commission has approved the project. If approved by the PLUM Committee, it will go before the full City Council for approval. 
