## At-risk youth find new home on Melrose Ave.

■ Facility is part of plan to alleviate homelessness

A former board-and-care facility in the Melrose area that was vacant for years is being renovated into a facility for youth at risk of becoming homeless.

The Los Angeles City Council approved a contract with Safe Place

for Youth on Aug. 20 to operate the 60-bed facility at the northwest corner of Melrose Avenue and Alta Vista Boulevard. An opening date has not yet been scheduled, but the city and Safe Place for Youth anticipate it will open in December or early 2026.

## BHUSD schools will display flag of Israel

■ Board votes 3-2 in support of resolution

The Beverly Hills Unified School District Board of Education narrowly approved a resolution on Aug. 26 that requires all schools to display the flag of the state of Israel on campuses during the month of May. The resolution, titled “Combating Antisemitism through Education, Awareness, Remembrance and Support,” recognizes May as Jewish Heritage Month, commemorates International Holocaust Remembrance Day in January, designates Oct. 7 as a day of remembrance, adopts the International Holocaust Remembrance Alliance’s working definition of antisemitism and provides professional development for staff and educational opportunities for students to learn Jewish history and prevent antisemitism. The resolution was created with the assistance of BHUSD’s legal counsel.

Board Member Russell Stuart said that BHUSD schools will not

fly the flag of Israel on flagpoles. However, the resolution does not specify how the flags will be displayed.

Board President Rachelle Marcus and Board Member Amanda Stern voted against the resolution, echoing concerns from the community over the display of the Israeli flag.

Marcus said that she wholeheartedly supported the intent of the resolution in combatting antisemitism and creating an inclusive environment for Jewish students, but felt that the display of Israeli flags would make the schools a target for increased hatred.

“I would pass this resolution

## New mural is ‘Nourishing the Community’

■ Project Angel Food unveils artwork at new campus on Vine Street

Visitors to Project Angel Food’s new headquarters will be welcomed by a mural featuring the hands and faces of community members at the heart of the organization’s lifesaving service. The mural was unveiled at a special ceremony on Aug. 27.

Project Angel Food, a nonprofit that cooks and delivers more than 1 million meals annually to people suffering from critical illnesses, unveiled the mural at the Chuck Lorre Foundation Campus, a new \$51.5 million facility. The renovated campus is set to open in December and will allow the organization to triple the number of meals it delivers each year. The mural, titled “Nourishing the Community,” was completed by internationally renowned artist and Boyle Heights

native Robert Vargas. It depicts four Project Angel Food volunteers reaching out and welcoming the community.

Vargas spent the hottest days of the summer outside painting the mural and bringing the volunteers who make and deliver food to Los Angeles’ most vulnerable citizens to life.

“I went into the kitchen firsthand to see the work that they do, and selected several volunteers and staff to participate and be a part of this mural, to truly be authentic to what they do,” he said. “These are the real angels that are making this happen and providing these meals to the community.”

Vargas started on Aug. 14 with 30 paint cans and worked completely freehand – without any projections or grids – to paint the faces of chef Veniece Hobby, lead driver Carla Ozuna, volunteer Mia McGovern and volunteer liaison Laura Martin-Marsh for anyone passing by on Vine Street to see. The quartet was present at the Aug. 27 unveiling. At the mural’s center is a Mexican matriarch, not based on any real person, meant to emphasize the significance of the Latino community in Los Angeles amid ongoing U.S.

## WeHo ditches Block by Block for Allied Universal

■ New vendor will offer same services

The West Hollywood City Council unanimously approved an agreement on Aug. 18 with a new security ambassador service, ending the city’s partnership with Block by Block.

A 20-month, nearly \$10.1 million agreement with Allied Universal Security Services was approved to take the place of Block by Block, which has provided security ambassadors to the city since 2013. Security ambassadors conduct unarmed security patrols by foot and bicycle, assist with special events and are stationed at kiosks throughout the city.

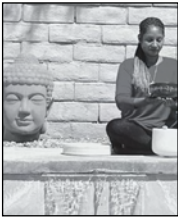
‘Fernandomania’

Young woman sought after disappearing on Aug. 21

A 20-year-old woman from Northridge went missing on Aug. 21 after visiting the Koreatown area. Her mother is asking for the public’s help in locating her daughter.

A report was filed with the Los Angeles Police Department’s Missing Person’s Unit, which is also actively searching for the missing woman – Jordan Pierce. Her mother, Alyze Pierce, said Jordan suffers from schizophrenia and does not have her medication. “I am very concerned because when she’s not on her medication, it makes her disconnected and delusional,” Pierce said. “She’s not in a good state of mind and not thinking clearly. It’s very concerning.”

Pierce said Jordan was released from a psychiatric hospital approximately two months ago and underwent outpatient treatment. Pierce said her daughter’s mental health was improving. On Aug. 20, Jordan went to Koreatown to visit a friend. Police said the missing woman’s last known whereabouts were near Vista Hermosa Park, near First and Toluca streets east of the Koreatown area.

Pierce posted information about her daughter’s disappearance on social media, asking for the public’s help. An unidentified person reported seeing Jordan on Aug. 23 at a gas station at Washington Boulevard and Comey Avenue in Culver City, but the report could not be corroborated, Pierce said.

When reached on Aug. 27, Pierce said her daughter is still missing and could be anywhere, including the Hollywood or Wilshire areas.

“I’m really concerned about her safety,” Pierce said. “I don’t know where she’s headed or what’s going on.”

Jordan Pierce, who goes by the nickname “Shy,” is white, 5-feet-3-inches tall and 110 pounds. She has a small tattoo of a dolphin under her left eye and a tattoo of black bars resembling “111111” on her neck.

Pierce asked that anyone with information text her at (310)883-5690. The LAPD’s Missing Person’s Unit can be reached at (213)996-1880.

Lawmakers seek answers on agents at press conference

U.S. Sens. Alex Padilla (D-Calif.) and Adam Schiff (D-Calif.) joined U.S. Rep. Laura Friedman (D-Calif.) and 12 other Democratic members of the California Congressional Delegation on Aug. 26 in demanding answers from the Department of Homeland Security officials about the DHS law enforcement presence outside Gov. Gavin Newsom’s Aug. 14 press conference in Los Angeles.

The media reported that approximately 100 federal agents – many in tactical gear and masks – were deployed directly outside the governor’s public event. Two individuals were reportedly arrested, raising concerns about the intent and proportionality of the operation.

“The American people must be able to trust that Immigration and Customs Enforcement, Border Patrol and related federal agencies will never use their authority to intimidate civilians on the basis of political or policy differences,” the lawmakers wrote in a letter to DHS Secretary Kristi Noem, U.S. Immigration and Customs Enforcement Acting Director Todd Lyons, U.S. Customs and Border Protection Chief Patrol Agent Gregory Bovino and U.S. Immigration

and Customs Enforcement Associate Director Thomas Homan. “Clear answers in this matter are vital to maintaining that trust.”

The lawmakers requested specific information about who authorized the deployment, the operational justification for its scale, whether the governor’s remarks influenced the decision and the two arrests made. In addition to Padilla, Schiff and Friedman, the letter was signed by U.S. Reps. Ted Lieu, Nanette Barragán, Judy Chu, Gil Cisneros, Robert Garcia, Jimmy Gomez, Sara Jacobs, Zoe Lofgren, Kevin Mullin, Luz Rivas, Brad Sherman and Juan Vargas.

Padilla has been a leading voice in opposition to President Donald Trump’s indiscriminate mass deportation agenda, including his unprecedented militarization of Los Angeles with the deployment of National Guard troops and active-duty U.S. Marines in response to overwhelmingly peaceful protests. He recently introduced the VISI-BLE Act to require immigration enforcement officers to display clearly visible identification during enforcement actions. For information, visit padilla.senate.gov.

# BHUSD OKs partial demolition of KBEV studio

■ Contract includes \$190,000 to tear down walls, ceiling

The Beverly Hills Unified School District Board of Education on Aug. 26 unanimously approved a \$190,000 contract with Integrated Demolition and Remediation, Inc. for the partial demolition and hazardous abatement of the KBEV studio on the Beverly Hills High School campus. KBEV, the school’s broadcast journalism program, was founded in 1969.

According to the district, hazardous materials containing lead and asbestos were found within the ceiling and walls of the studio. The demolition will include the removal of the dropped ceilings, doors, non-load-bearing walls, windows and existing partitions. Studio features such as rigging systems, theatrical lighting systems and all structural steel elements will remain in place. The construction will begin immediately and is expected to complete within three weeks. Following completion of the demolition, a plan for the updated design of the studio will appear before the board for discussion.

BHUSD Board members praised the project at the meeting on Aug. 26.

“At some point last year, our community was thinking that we are moving away from the Career

Technical Education programming, and I think it’s great that we just keep showing them that we are reinvesting and reinvesting into these experiences and programs,” Board Vice President Judith Manouchehri said.

“From the equipment, which is completely outdated, the style and layout which is completely outdated, we have not been giving our kids the abilities to learn the latest and greatest techniques in film and television,” Board Member Russell Stuart said. “It’s been neglected.”

Although the district approved the demolition on Aug. 26, KBEV students and parents had previously raised concerns over the renovation, which appeared to begin earlier this summer. In July, students photographed items including furniture and equipment being removed from the studio before a renovation had been announced. Journalism students and parents were distraught over the retirement of Romeo Carey, the longtime director of KBEV who left the district earlier this year.

While KBEV previously provided live broadcasts of board meetings, in which students would operate cameras and recording equipment, gaining real-life broadcast experience, the board eliminated KBEV’s role in the public meetings upon Carey’s retirement. Live recordings of the meetings are now overseen by a district employee.

Additionally, on Aug. 5, the BHUSD Board of Education

approved a policy that expands district oversight of district-affiliated social media pages, including KBEV. The resolution prohibits “personal opinions or commentary.”

Several alumni who were KBEV students in high school are worried about the future of the program.

“Without giving students the freedom and the rights to create the content, you’re sending a message that their speech, that their thoughts, that their ideas are no longer allowed to be broadcast,” class of 2010 graduate Nikkie Sedaghat said.

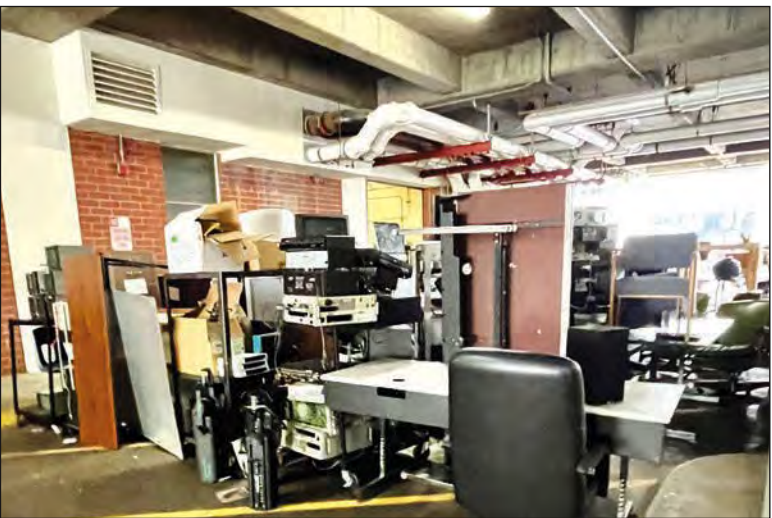

## BHUSD considers limiting tutoring

■ Policy would prohibit teachers from tutoring their own students

The Beverly Hills Unified School District Board of Education will consider limiting the ability of teachers to tutor their students.

The proposal is an amendment to Board Policy 4136 on non-school employment, which outlines paid activities incompatible with district employment. The proposed amendment adds that “district teachers may not tutor students currently enrolled in any of their classes.” Additionally, it states that district teachers are prohibited from tutoring – whether paid or unpaid – any students currently enrolled in the district “if such tutoring involves the disclosure and/or use of

information not equally available to all students.”

The policy also prohibits teachers from organizing or conducting group tutoring sessions for students enrolled in the district. It permits teachers to tutor students not enrolled in the district, “provided that no district resources, facilities or instructional materials are used, and provided further that such tutoring does not conflict with the employee’s duties or responsibilities to the district.”

The board approved the first reading of the policy. However, Board Member Dr. Amanda Stern said she would like to discuss the policy further before a final approval.

BHUSD Superintendent Dr. Alex Cherniss instructed board members to email him with their possible concerns. Cherniss indicated that he will incorporate any

# Urbn Leaf Dispensary on Sunset Strip burglarized

■ Deputies confirm business was targeted four times this year

The Urbn Leaf West Hollywood Cannabis Dispensary was burglarized on Aug. 25 for the fourth time this year. The door of the dispensary, located at 8477 Sunset Blvd., was shattered around 4:34 a.m., setting off the store’s alarm. However, sheriff’s deputies did not locate anyone inside and made no arrests, Lt. Ashley Turner of the West Hollywood Sheriff’s Station said. Additionally, nothing appeared to have been stolen, Turner added. “At the time of the report, the person at the location associated

with the business did not believe anything had been taken,” she said. The store, which was the first cannabis dispensary on the Sunset Strip, was broken into three previous times this year, with burglaries occurring on Jan. 9, Feb. 6 and April 20. A separate burglary was reported at The Woods WeHo in May, a cannabis dispensary on Santa Monica Boulevard in West Hollywood owned by comedian Bill Maher and actor Woody Harrelson. Deputies do not have information on any suspects. Anyone with information regarding the burglaries is asked to contact the West Hollywood Sheriff’s station at (310)855-8850. Representatives from the Urbn Leaf West Hollywood Cannabis Dispensary declined to comment.

# Menendez brothers denied parole

■ Decision comes after resentencing hearing in May

Brothers Erik and Lyle Menendez were denied parole on Aug. 21 and 22, respectively, following separate hearings that each lasted over 10 hours. The brothers were sentenced to life in prison without the possibility of parole in 1996 for the double murder of their parents, Jose and Kitty Menendez, which took place in their family home in Beverly Hills. In May, Los Angeles Superior Court Judge Michael Jesic resentenced the brothers to 50 years to life in prison with the possibility of parole, opening the door for the August review by the parole board. However, the separate hearings found that the brothers were not suitable for parole for several reasons. Board commissioners said that Erik was not rehabilitated because he possessed a cellphone, associated with a prison gang and was involved in a tax fraud scheme. They noted his behavior as “selfish” and raised concerns about his actions. Parole Commissioner Julie Garland said that while Lyle outwardly displayed signs of rehabilitation, he still showed “antisocial personality traits like deception, minimization and rule breaking that lie beneath the positive surface.” Lyle also possessed an illegal cell phone while in prison. Erik and Lyle Menendez can reapply for parole in three years. However, with good behavior, they may appear before a parole hearing in as little as 18 months.

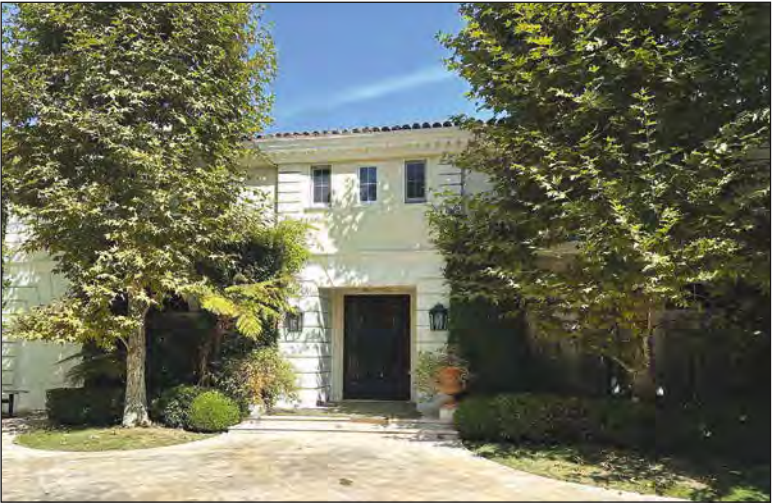

Los Angeles County District Attorney Nathan Hochman praised the parole board’s decision in a statement. “The parole process is guided by evidence and public safety, not by spectacle, shifting public opinion or personal agendas,” Hochman said. “After weighing the facts, the board’s analysis was consistent with that of our office – both Menendez brothers remain unsuitable for release. Independent psychological evaluations further classify them as presenting a moderate risk.” The family of the Menendez brothers – who have been supportive of their potential release from prison – released a statement following the parole decisions stating that they were “disappointed” but “not discouraged.” “The process for parole is exceptionally rigorous, but we are incredibly proud of how Erik and Lyle showed up – with honesty, accountability and integrity,” the statement

read. “This is not the end of the road. Both will go before the board again, and their habeas petition remains under review. In the meantime, we know they will take time to reflect on the board’s recommendations and will continue to lead, mentor and build programs that support rehabilitation and hope for others. We know they are good men who have done the work to rehabilitate and are remorseful. We love them unconditionally and will continue to stand by them on the journey ahead.” In addition to future parole hearings, the brothers have two other possible pathways to freedom. Gov. Gavin Newsom can grant clemency at any time in the form of a commutation, which would reduce their sentence, or a pardon. Additionally, the brothers submitted a habeas corpus petition in 2023 which seeks a new trial based on evidence that was not previously presented in court. The petition is currently under review.

# Burglary crew linked to Wilshire area break-ins

Ten members of a burglary crew are in custody for a series of nearly 100 break-ins throughout the city, including in the Wilshire area. Los Angeles Police Department Chief Jim McDonnell, Los Angeles County District Attorney Nathan Hochman and Mayor Karen Bass made the announcement on Aug. 25. The suspects are all gang members, authorities said. The group, nicknamed the “Rich Rollin Burglary Crew,” targeted residences for luxury goods such as jewelry and handbags. Police linked the suspects to at least 92 burglaries in Los Angeles since 2022, with most of the break-ins reported in 2024 and 2025. Seven suspects were arrested in an extensive operation on Aug. 20. They are identified as Devon Collier, 37; Tyrone Tisby, 47; Frank Tisby, 38; Jeremy Shepard, 38; Jermaine Kimbrough, 22; Michael Lewis, 20; and Marquell Lewis, 26. They were booked on burglary charges and possession of controlled substances while armed. Eric Cannon, 40, also accused of being part of the crew, surrendered on Aug. 22. Defendants Anthony Leslie and Shawn Quinney, both 36, were already in custody on unrelated charges. “These arrests send a clear message, if you prey on our neighborhoods, we will find you and hold you accountable,” McDonnell said. “What made this takedown possible

was the outstanding work of our officers and detectives – communicating across divisions and bureaus, sharing intelligence and connecting the dots that revealed these burglaries were tied to the same crew. This operation is the result of more than two years of relentless investigation.” “Together – with our partners and our community – we are taking back our neighborhoods,” Hochman said. “At the District Attorney’s Office, we are committed to protecting our communities and will use every tool under the law, including strikes and sentencing enhancements, to hold these defendants fully accountable. My office will not hesitate to seek the maximum penalties under the law. If you commit these crimes, you are choosing prison over freedom – possibly for life.” A majority of the burglaries occurred within the LAPD’s West Los Angeles Division, which led the investigation. In February 2025, police arrested three of the suspects following a pursuit of a van connected to two burglaries. The arrests led to additional suspects. In April, detectives served a search warrant at a residence connected to the crew and recovered rifles, handguns, ammunition, body armor, large-capacity magazines, jewelry, watches, stolen credit cards, fake IDs and multiple license plates. During the arrests on Aug. 20, authorities seized 15 firearms, burglary tools and stolen property. Police said the evidence showed organization and

directly tied the crew to multiple burglaries. Lt. Mark Ro said six burglaries are connected to the crew in the Wilshire Division. They occurred in Hancock Park, the Melrose area and Beverly Grove, but he did not have the exact locations or dates. Ro said investigators are still working

# Man arrested for break-in at Lionel Richie’s home

A suspect was arrested following an attempted break-in at singer Lionel Richie’s home in Beverly Hills shortly after midnight on Aug. 22, according to media reports. While the Beverly Hills Police Department did not confirm the exact address or that the home belongs to Richie, BHPD Lt. Kevin Orth said that the department received a call at approximately 12:11 a.m. of an attempted burglary in a neighborhood adjacent to the Los Angeles Country Club. Orth said officers located the suspect near Wilshire and Beverly Glen boulevards. The suspect was identified as 38-year-old Michael John Bond Jr. Orth added that the investigation is ongoing, and did not confirm whether anything was taken from the house.

together to pinpoint where all of the burglaries occurred, and added that the number of incidents in the Wilshire area will likely increase. However, he said for the first time in the three years he has worked at the station, no burglaries occurred in the Wilshire Division over a full weekend, from Aug. 23-24. “I don’t want to jinx it, but it’s pretty significant that we saw no burglaries,” he added.

Bass said that the complex operation and arrests mark a breakthrough in addressing property crime in Los Angeles. While many of the break-ins occurred on the Westside, the crew also targeted residences in the San Fernando Valley. “Thanks to the tireless work of our officers and detectives, this crew, which has victimized families and businesses, is no longer a threat to our neighborhoods,” Bass said.

# TV host robbed in Beverly Hills

■ Camille Anderson says she was attacked while walking

Camille Anderson, an actress and model known as the host of the “Selling Mega Mansions” reality television series, was assaulted and robbed on Aug. 16 while walking near Cañon Drive and South Santa Monica Boulevard in Beverly Hills. The robbery took place at approximately 9 p.m. as Anderson was walking to a restaurant with a friend, she said. “I was thrown to the ground very forcefully, like body slammed into the ground,” Anderson said in a social media post. She said two men attacked her and stole her Yves Saint Laurent purse before fleeing

in a vehicle. Anderson said bystanders called 911 and the BHPD responded immediately. She said officers took a report and informed her within minutes that the suspects were caught. “The Beverly Hills Police Department did a phenomenal job. They were super fast acting,” Anderson said. “They deployed everyone available. They found them quickly. It seemed like literally within 10 minutes.” BHPD Lt. Kevin Orth confirmed that the department responded to a report of a robbery in the area at approximately 9:08 p.m. on Aug. 16. Three suspects were arrested on robbery and conspiracy charges. The BHPD identified the suspects as Razmik Papikyan, 25, Vahagn Grigoryan, 45, and Vlad

Oganisyan, 23. The Los Angeles County District Attorney’s office filed felony robbery charges against Grigoryan on Aug. 19. According to the D.A.’s office, Grigoryan posted \$100,000 bail and is not in custody. His arraignment is scheduled for Sept. 8. “The cases against Razmik Papikyan and Vlad Oganisyan were sent back to law enforcement for further investigation,” a D.A. spokesperson said. Anderson believes she was targeted because of her designer purse and jewelry, and cautioned others not to wear luxury accessories while walking. “I just want to get this message out there to take safety so seriously in Los Angeles,” she said. “It’s a really big problem. I’ve now been mugged in Beverly Hills, I can say. That’s so sad. I’ve been here for a long time in this city. I love it so much, and it’s just really changed.”

# Crash damages statue of early Hollywood icon

The driver of a white van careened onto a traffic median and crashed into the Four Ladies of Hollywood Gazebo at Hollywood Boulevard and La Brea Avenue around 5:50 p.m. on Aug. 25 before

fleeing the scene, police said. Witnesses called 911 and reported that the van was driving away, Los Angeles Police Department spokesman Kevin Terzes said. Officers were unable to locate the vehicle. A report was taken and officers determined the van also struck

another vehicle in the area, Terzes said. No injuries were reported. The 30-foot-tall Four Ladies of Hollywood Gazebo, a prominent fixture on the triangular median at the southeast corner of the intersection, was installed in 1993 as part of a redevelopment project to revitalize the western edge of the Hollywood Walk of Fame. It features statues of early Hollywood icons Dorothy Dandridge, Dolores Del Rio, Mae West and Anna May Wong, which form the pillars underneath the gazebo top. The van struck the statue depicting Wong, widely considered to be the first Chinese American Hollywood film star. The collision damaged the statue, but the pillar supporting the gazebo remains in place and the gazebo is still standing. It is unclear whether plans are being formulated for repairs. The driver, only described as a male, is wanted for the hit-and-run. The vehicle that struck the statue is a full-size, older model, white work van. # Subway project keeps rolling in right direction

Crews are working at and around Metro subway station sites in late August and early September along the D Line Extension project. New stations at Wilshire/La Brea, Wilshire/Fairfax and Wilshire/La Cienega are being completed ahead of the anticipated opening of the subway line’s first segment in late 2025. Streetscape improvements continue along Wilshire Boulevard in the Miracle Mile, and on Wilshire Boulevard between San Vicente and La Cienega boulevards in Beverly Hills. A K-rail work zone remains in place on the south side of Wilshire Boulevard east of La Cienega Boulevard, and temporary road closures are being implemented on South Hamilton and South Tower drives. Two lanes remain open in each direction on Wilshire Boulevard between San Vicente and La Cienega boulevards. The traffic control supports construction of new curbs, sidewalks, pedestrian ramps and tree wells. Work may extend into night hours. Heavy equipment may be used until 9 p.m. on most nights. Ongoing construction also continues at the Beverly Drive Station,

formerly the Wilshire/Rodeo station. Traffic lane and sidewalk closures are in place through Aug. 29 on Wilshire Boulevard between Stanley and Hamel drives and Wilshire Boulevard between Carson Road and Robertson Boulevard to support the removal of geotechnical instruments. The work occurs at night from 8:15 p.m.-7 a.m. The south sidewalk on Wilshire Boulevard between Cañon and Crescent drive is closed through Sept. 26 for underground construction. Wilshire Boulevard is reduced to two lanes in each direction, with phased sidewalk restrictions and

pedestrian detours in place. Local access is maintained. Ferrari Beverly Hills customers can enter from the rear of the property, with valet parking available at the nearby Sixty Hotel. Preparations are underway to remove deck panels near the Century City Station. Crews will restore Constellation Boulevard between Century Park East and Solar Way. # Drone program awaits flight in WeHo

■ No drones have yet been used to respond to crime

Public safety officials provided an update on West Hollywood’s drone program at the Aug. 25 Public Safety Commission meeting. On June 23, the West Hollywood City Council approved the use of drones for emergency response while it awaits sign-off from the Sheriff’s Department on the city’s larger drone program. No drones have been deployed yet to respond to crimes in the city, though the West Hollywood Sheriff’s Station was given one drone by the Sheriff’s Department.

At the Public Safety Commission meeting, Sgt. Jason Duron of the West Hollywood Sheriff’s Station said the city’s drone as first responder program would allow deputies at the station to fly drones remotely to emergency crime scenes before deploying deputies to the area. However, the Sheriff’s Department’s current plan only allows drones to be deployed by deputies out in the field who respond to calls that meet a certain level of emergency and then gain approval from the department’s Special Enforcement Bureau before flying the drone. The instances that drones can be used include “explo-

sive ordnance detection missions, disaster response, barricaded suspects, hostage situations and active shooters.”

“That drone would be in the air over the situation where the deputy on scene at the location would be able to see what’s going on,” Duron said. “It wouldn’t be transmitted back to the station.”

Once the revision to the Sheriff’s Department drone policy is completed, the West Hollywood Sheriff’s Station will review its own drone policy to see if significant changes need to be made before the drone as first responder program is implemented.

“We are working with the Sheriff’s Department,” director of community safety Danny Rivas said. “What they end up proposing to us is going to be something that’s blanketed across the entire county of Los Angeles. So, what we approved and what we’ll end up seeing as what their final proposal is – we don’t know what that’s going to look like yet. At that point as we’re cross-referencing between the two, we’ll identify if there are significant changes or things we need to bring back for discussion.”

Any significant revisions to the program would be implemented after community and commission input, Rivas said. He added that the West Hollywood Sheriff’s Station is still able to deploy a drone in life-threatening situations while waiting

for the policy revisions from the Sheriff’s Department.

Public Safety Commissioner Catherine Eng also discussed potential issues adhering to a countywide public safety policy.

“It’s a concern for most of us that our vibe and personality here is very different,” she said. “The nature of how our city is run is different – so I do want to point that out.”

Rivas added that the city will disseminate more communication on the drone program to the city. There is no update on when the Sheriff’s Department policy will be completed.

## WeHo starts annual tree trimming

The city of West Hollywood will start annual tree pruning on Tuesday, Sept. 2, with work expected to continue through February.

West Coast Arborists will start the pruning work along Sunset Boulevard, taking measures to avoid disruptions to westbound traffic lanes before 10 a.m. to minimize the impact on morning commuter traffic. During the coming weeks, crews will move to Santa Monica Boulevard, Beverly Boulevard and main streets in West Hollywood. After trimming in commercial areas is complete, trimming will commence on residential streets. Work hours are 8 a.m.-3 p.m.

The city will use several methods to notify residents, businesses and motorists in advance of pruning work. “No parking” signs with information about scheduled trimming activities for each day will be placed a minimum of 24 hours in advance of work. Door hangers and signs posted on trees will be placed

a minimum of 72 hours in advance of residential tree trimming activities. Electronic message boards at strategic locations will notify the public several days before trimming and during trimming work. Information will also be posted on the city’s social media pages and at weho.org.

# WeHo Library installs new temporary art

The city of West Hollywood’s Arts Division has installed two new temporary art exhibitions at West Hollywood Library on Aug. 7.

“Angel of Compassion” is a series of seven mixed-media paintings by artist S.P. Harper and “Cacti” is a trio of ceramic and metal sculptural totems by artist Dustin Gimbel. The exhibitions are available to view during regular library hours.

“Angel of Compassion” is a series of seven paintings by artist S.P. Harper featuring images of jewels that were originally owned by Elizabeth Taylor and sold by her estate to benefit the Elizabeth Taylor AIDS Foundation after her death. Prior to their auction in 2011, these jewels were displayed on a four-stop worldwide tour, including at the Pacific Design Center gallery space across the street from West Hollywood Library. Taylor was one of the first celebrities to participate in HIV/AIDS activism. She helped to raise more than \$270 million for the cause and received the Presidential Citizens Medal in 2001 for her philanthropic efforts.

Harper paints and sculpts abstract geometrics using recycled materials. What begins as refuse is repurposed, transforming base materials into noble objects.

“Cacti” (“Euphorbia,” “Monstrosus” and “Mod Cactus Trio”) is a trio of ceramic and metal sculptural totems by artist Dustin Gimbel. These totems stand as a reflection on xeriscaping, a practice that embraces drought-tolerant landscapes to conserve water in an era of increasing scarcity.

Gimbel is a sculptor and designer whose work is deeply influenced by his fascination with plants and the natural world but also manmade forms, often exploring the intersection between the two.

Other current exhibitions at the West Hollywood Library include “Remembering Beverly Park,” a display of historic photographs of the children’s amusement park formerly located just outside the border of West Hollywood; “Historic WeHo, Architectural Details,” a selection of architectural details of West Hollywood’s historic buildings as taken by Tony Coelho; “West Hollywood Park,” a painting by Jay Lynn Gomez highlighting invisible labor forces and “Platanus Bibliotechalis,” a permanent, site-specific sculpture of an imaginary sycamore tree by

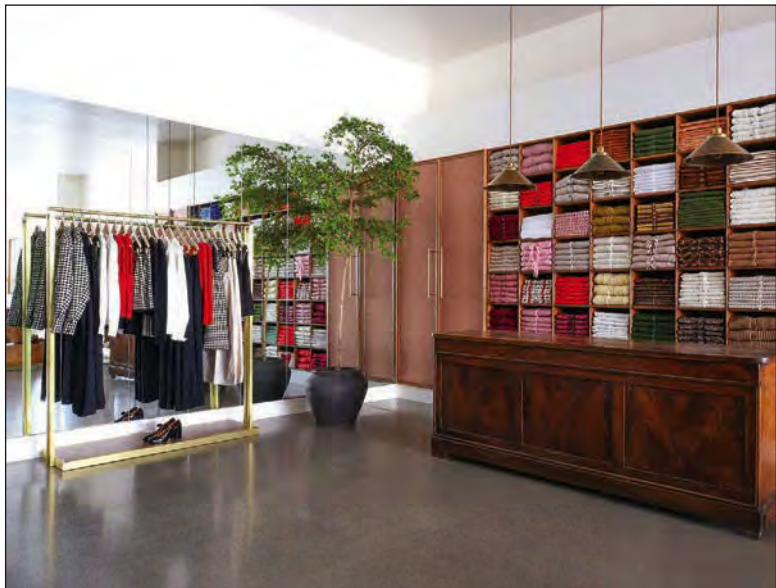

Beverly Hills sides with developer, not residents, on bond issue

Re “Council approves bonds for One Beverly Hills,” Aug. 21 issue

On Aug. 19, despite significant opposition, the BH council agreed to orchestrate a \$550 million Mello-Roos bond indebtedness for the benefit of the One BH development.

The One BH project is an overly ambitious dual skyscraper luxury condo and Aman hotel project adjacent to the Beverly Hilton. The project’s lack of progress has been intentionally blocked from public view, but it appears that only incomplete demolition and digging have taken place.

A big selling point for the original approval was the promise that 4.5 acres of botanical gardens and Merv Griffin Way improvements would be constructed and maintained for public use. So these limited public amenities were used to support a Mello-Roos bond issue, generally used for projects with overwhelming public benefits – not luxury projects.

Council members asked the right questions. But regardless of the answers, council members and staff were more interested in trying to help what appears to be a failed development than observing their duty to protect the city.

The council required no showing of assets and liabilities and no completion guarantee. The council emphasized that the bond payments would be assessed only to property owners within the One BH project area, and there was little consideration of the risks the city would face due to its involvement.

A big incentive to orchestrate the bond indebtedness was that the city would receive \$10 million of the bond proceeds to spend on city facilities. However, city staff purposely concealed that the \$10 million can only be spent on city facilities either within the One BH project area—the public portion of the botanical gardens and Merv Griffin Way—or for city facilities which directly serve and have a nexus to the One BH project.

Also concealed from the public in the agenda report were requirements for the city’s extensive ongoing involvement in the construction, bids, hiring, contracts, inspections, payments, etc., for the public portion of the botanical gardens and Merv Griffin Way and the levying and collection of bond taxes in addition to the orchestration of bond sales.

Some of our council members seemed to be motivated by an off-kilter obsession with luxury and “the Beverly Hills brand,” and appeared to be working for the owners of One BH – not the city and its residents.

SB 79 illustrates battle over local government rights vs. state overreach

The article fails to mention some important information that helped

to support the council resolution against SB 79 and that have nothing to do with siding with or against homeowners.

The truth of the matter is that SB 79 is a bad bill. It is an unfunded mandate that requires the city to provide infrastructure and services for developments that could be placed anywhere in the city within a one-half mile of transit without regard as to whether infrastructure is adequate to support it. The cities are left having to pay for improvements scattered here and there without a plan as decisions as to where projects are built would be left to developers, speculators and investors whose driving criteria is to maximize profit – not build livable, sustainable communities. That is the city’s job, and SB 79 overrides the city’s housing element, the city’s state-approved housing plan crafted with significant community input and participation.

Wiener’s bill also would allow the developments to be built within a half mile of where transit routes are planned. However, a plan which is a line on a map and that has no funding may not be built for many years. SB 79 projects could be built in the community without the benefit of “planned” transit to serve the added density for many, many years.

The debate should not be framed as one that sided with homeowners; it represents a much larger battle over the rights of local governments vs. the overreach of the state with one-size-fits-all policies that fail to address the diversity and needs of cities and counties across the state.

# Hammer Museum offers last chance to see Noah Davis exhibition

Don't miss the Hammer Museum's first institutional survey of the late Noah Davis (1983–2015), which runs through Sunday, Aug. 31.

The exhibition is the first U.S. institutional survey of the visionary artist. It marked a meaningful homecoming to Los Angeles, where Davis lived, worked and left an enduring legacy. The exhibition features more than 50 paintings, blending realism and dreamlike imagery to explore themes of fami-

Organized chronologically, "Noah Davis" offers a comprehensive overview of his practice, including his curatorial and community-building efforts as co-founder of the Underground Museum, Los Angeles. The exhibition traces Davis's career from 2007 until his untimely passing in 2015, featuring works that delve

into his exploration of politics, current affairs, everyday life, ancient Egypt, family history, racism in American media, art history and architecture. His paintings are presented alongside experimental works in sculpture and works on paper, offering a deeper look into the conceptual foundations of Davis' practice. The exhibition also includes a selection of Davis' eclectic source material on display for the first time.

"Noah's career was tragically cut short but nonetheless extraordinary, as this internationally touring exhibition demonstrates," Hammer Museum director Zoë Ryan said. "He was also a great supporter of artists who felt overlooked by other institutions, and through the Underground Museum created a welcoming space for artists and audiences alike, greatly enriching the cultural fabric of this city. This exhibition is a celebration of Noah's life and legacy."

Highlights include "40 Acres and a Unicorn" (2007), a striking blend of fantasy and history; "Isis" (2009), a portrait of his wife Karon depicted as the titular Egyptian goddess of magic and the "Pueblo del Rio" series (2014), paintings that reimagine one of the oldest, largest and most architecturally significant public housing developments in Los Angeles.

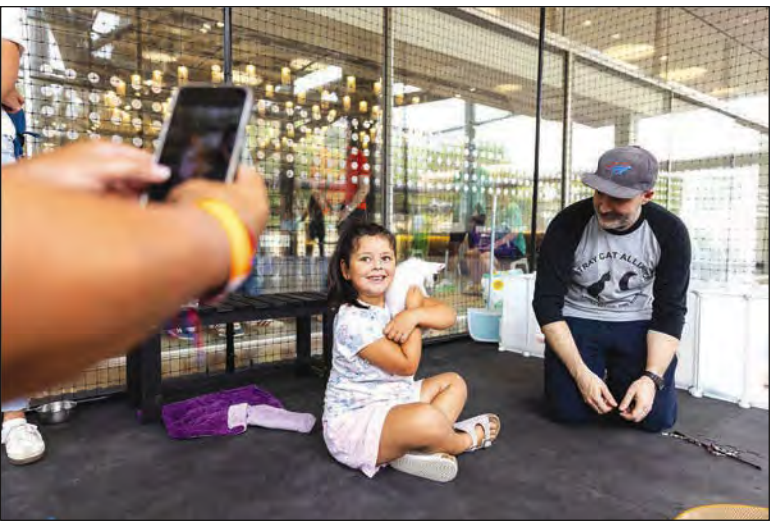

L.A. responds in aftermath of Hurricane Katrina

Katrina Evacuees Arrive in Los Angeles

Organizations Both Public and Private are Sending Aid to the Devastated Region

New Orleans was Site of Junior Olympics Competition 4 Weeks Ago

One month ago, our family was in New Orleans for the Junior Olympics, where our daughter was competing. Over 30,000 athletes

In the aftermath of Hurricane Katrina's devastating destruction in Louisiana and Mississippi, the country has come together to aid the victims. Los Angeles is no exception, with organizations throughout the area donating time, money and supplies to help the victims of Katrina.

On Tuesday, more than 300 evacuees from New Orleans and the surrounding area arrived in Los Angeles, and are being housed at the Los Angeles Dream Center, which is located in the old Queen of Angels Hospital in Echo Park. Many of the hurricane victims had lost family members in the disaster, and have come to California with only a few belongings, and an uncertainty about their future.

"People were trying to get food and water for their kids, but these wasn't anything left," said Taisha Blackwell, who fled last week from her home near

The Beverly Press and Park Labrea News’ Sept. 8, 2005, issue focused on the devastating effects of Hurricane Katrina, which made landfall on the Gulf Coast near New Orleans 20 years ago on Aug. 29, 2005. The costliest hurricane in United States history, Katrina resulted in \$108 billion in damage and was among the deadliest with 1,833 fatalities, according to the National Weather Service.

Vast areas of New Orleans and the surrounding area were flooded, causing many to flee the city. Taisha Blackwell and her daughter, Tramaine Cowart, shown on the cover of the Sept. 8, 2005, issue, fled their home near downtown New Orleans through a program providing temporary shelter at the Dream Center in Los Angeles. The faith-based charitable organization in the former Queen of Angels Hospital building in Echo Park housed 300 Louisiana residents, part of a massive local relief effort.

L.A. County and the city of L.A. sent more than 80 search and rescue personnel to Louisiana and worked with charitable organizations to provide financial assistance and help residents. The city of West Hollywood activated the West Hollywood Responds program to solicit donations and worked with the American Red Cross and Operation USA, a West Hollywood-based charity. The Jewish Federation of Greater Los Angeles raised more than \$500,00 in donations. Multiple telethons benefiting Hurricane Katrina survivors were also held over Labor Day Weekend in 2005 including the Jerry Lewis Multiple Dystrophy Association Telethon, which was held at the Beverly Hilton and donated \$1 million to the relief effort.

# ‘Nobody 2’ is just fine

The idea of “Nobody” is more enticing than the films themselves. A retired assassin tries to live a normal life, but the call of the wild is always nigh. It’s John Wick in the suburbs. Add Bob Odenkirk, and the franchise should be several home runs. That’s half true.

Like its predecessor, “Nobody 2” is a fun, midrange action flick. Creative fight sequences, menacing baddies and lots of Odenkirk as Hutch Mansell, failing to diffuse tension and reconnect with his family.

This time, his loved ones know his secrets (to some degree), but that doesn’t excuse how much of their lives he now misses. He owes some unsavory folks a lotta money (more on that in the first film), so the former assassin gig is now the main hustle. After several successful jobs – bloody, they may be – he needs a break. He misses his family and plans a special holiday to a getaway spot that meant so much to him as a child.

Unfortunately, Hutch’s son Brady (Gage Munroe) seems to

have anger issues like his old man. One punch in an arcade sets off a series of events. Hutch endures one of many encounters with local leaders like Sheriff Abel (Colin Hanks) and theme park owner Wyatt (John Ortiz). They aren’t fans.

It turns out this town is into something below board, but Hutch doesn’t uncover the truth in time. He’s in too deep, quickly leading to an explosive confrontation with the film’s big boss, Lendina (Sharon Stone). Don’t expect much from Stone. Normally, she’s an on-screen titan. Not sure what’s going on here. She’s a run-of-the-mill villain with little else going on.

Expect the whole family to get involved. Former FBI agent and grandpa David (Christopher Lloyd) hangs out until he’s needed. Hutch’s brother Harry (RZA) is just a phone call away, though he also delivers one of the film’s worst one-liners – a variation on bringing a knife to a gun fight.

Becca (Connie Nielson), Hutch’s better half, does a bit more this time around. We see how she handles a rifle and encourages Hutch to be better.

The “Nobody” formula is now established. The dad has trouble balancing family life and a bloody past. His attempts to do the right thing make matters worse – so does his temper. Luckily, his family is there to help along the way.

Everything about these films is fine. Not great, just fine. That shouldn’t be a negative comment. If only more original streaming films took cues from the “Nobody” flicks. Those films normally can’t even reach fine. But the “Nobody” series is the brainchild of screenwriter Derek Kolstad, who created John Wick and penned three of

those films. Perhaps “fine” should be a bit more.

A major frustration is how “Nobody 2” features its best combat sequences in the first 10 minutes. Others are – you know – fine, but far less memorable. A gory close-up here, an explosion there. It should be a much bigger deal, one worthy of a theater outing.

Watching films on a TV or your phone will never compare to the big screen experience. Still, “Nobody 2” doesn’t need to be viewed on a 60-by-35-foot screen. It’s a renter or maybe something you see when it’s available on Peacock.

# State Superintendent announces commitment to reduce chronic absenteeism

State Superintendent of Public Instruction Tony Thurmond was joined by Assemblyman Al Muratsuchi (D-Los Angeles), State Sen. Sasha Renée Pérez (D-Alhambra) and education leaders to announce that California is on track and committed to reduce chronic absenteeism by 50% over five years. Superintendent Thurmond announced the release of new guidance to improve student attendance statewide, developed in partnership with Attendance Works and the California Collaborative for Educational Excellence.

Attendance Works Vice President of Programs Cecelia Leong, California Collaborative for Educational Excellence Deputy Executive Director Sujie Shin, Folsom Cordova Unified School District Superintendent Erik Swanson, FCUSD Child Welfare and Attendance Specialist Maggie Cunin and FCUSD student repre-

sentatives also spoke about the importance of promoting school attendance and supporting families to get students to school.

Rates of chronic absenteeism in FCUSD mirror statewide trends, and Swanson credits the district’s receipt of a California Community Schools Partnership Program grant as a “game changer” for improving

school attendance.

As a former social worker, Thurmond noted the importance of Community Schools strategies for improving school attendance.

“When our students aren’t showing up to school, our schools need the resources to knock on doors and ask why,” he said.

# Drive sober or get pulled over on Labor Day weekend

# Defendant sentenced for fraud, money laundering scheme

A female defendant who was living in Koreatown was sentenced on Aug. 14 to 28 months in federal prison for laundering approximately \$3.5 million in money stolen from victims of investment scams, including opening bank accounts used to launder the money and picking up packages of bulk cash sent by fraud victims.

Li Liu, 27, aka Qiunan Li and Xiaoying Zhao, was sentenced by United States District Judge Fernando M. Olguin. She pleaded guilty on June 4 to one count of conspiracy to commit money laundering. Liu is a Chinese national, authorities said. Liu’s co-defendant, Shau Li, 28, of Koreatown, is facing 20 years in federal prison for his role in the scheme.

In September 2024, Liu – using a fake passport under the alias Xia Ran and other documents – opened a bank account for a fake company named Ocean X Trading Ltd Inc. and had access to the account until April 2025. Multiple investment scam victims wired money to the account. During October 2024

alone, Liu transferred \$83,461 out of the bank account to the Hong Kong-based company Alamo Tech Ltd.

As part of the conspiracy, Liu and her co-conspirators also used fake IDs – including passports and California driver’s licenses – to open accounts at mail receiving facilities, where packages of bulk currency sent by wire fraud victims were picked up. For example, Liu – using a fake passport with the name Qiunan Li and documents for a business called Sunny South Trading Inc. – opened an account in March 2025 at a shipping company in Koreatown, authorities said. During two days in April, six packages containing bulk cash were received at the location. Liu picked up, opened and photographed the packages’ contents, consolidated the money and sent it to Lyu and other co-conspirators.

Authorities searched Lyu’s cell-phone and found approximately 46 images of bulk currency, many of which Liu sent to him. Law enforcement estimated that the bulk currency in the images totaled approxi-

mately \$3.5 million in laundered money.

The conspiracy also used couriers to deliver bulk cash from fraud victims. In March 2025, Liu was involved with an unnamed individual who transported more than \$200,000 in bulk currency belonging wire fraud victims from Dallas to Los Angeles.

Liu admitted in a plea agreement that she received payment for laundering the fraudulently obtained money. Law enforcement agents searching Liu’s residence found \$104,000 in cash from fraud victims that had not yet been sent to other co-conspirators. Authorities also recovered 27 packages that Liu and Lyu had not picked up from mail receiving facilities, which were found to contain about \$285,000 in cash and \$87,000 in gold bars.

Lyu, who is from China and was in the United States illegally, also pleaded guilty on June 4 to one count of conspiracy to commit money laundering and faces up to 20 years in federal prison at a Sept. 4 sentencing hearing.

Immigrations and Customs Enforcement raids. L.A. County Supervisor Lindsey Horvath, 3rd District, and Ivette Aragon, district director for U.S. Rep. Jimmy Gomez (D-Los Angeles) were present at the unveiling.

“It’s truly special that these are real people of our community who give of themselves, who have dedicated their time, their talent, their heart and their spirit to a wonderful organization – Project Angel Food,” Horvath said. “The faces that you see are not only real people who do this work, but reflective of our diverse community who is served by this work. It is a symbol that... all are welcome to be served by their work. We do not exclude. We do not turn you away. This is a place of

welcome. This is a place of nourishment. This is a place of service.”

“Right behind us is the Project Angel Food kitchen and food preparation center under massive renovation. It is a huge renovation. It is going to become a beacon of hope and healing for Los Angeles,” Project Angel Food CEO Richard Ayoub said. “There’s so much transformation happening on the inside, we decided we’ve got to have something that matches it on the outside. [We had] this beautiful white wall, and we need to make it into a cultural landmark.”

Ayoub said Vargas was the only person he knew who could do it.

Beyond the volunteers, Vargas said he met a nearby street vendor selling tamales while working on the

painting. He realized how the tamale vendor actively nourishes the surrounding community, and decided to model the hands in the mural after hers.

“As I’m watching her prepare this food, it occurred to me that it would be great to incorporate her into the piece with this idea of permanence, and showing that she, too, has a seat at the table and a place here,” Vargas explained.

At the unveiling, Vargas dedicated the painting to his mother and was thrust into the air by a forklift, where he signed the mural. Above all, “Nourishing the Community” is a tribute to Los Angeles, he said, a place that is welcoming to all no matter their background.

“[Project Angel Food] is about

supporting people who are in need, not based on anything else other than just supporting their fellow human no matter what the age or the

condition or the ethnic background,” he said. “We’re all in this together. And this mural is a bit of a micro-cosm of the greater L.A. area.”

# BHUSD plans to display flag of Israel

tonight, but I have a deep concern about ... flying a flag or displaying a flag in front of the school,” Marcus said. “I fear [for] the safety of the students in the school. I don’t want to put something on the front of the school that would make us targets of any kind, especially with the students in our school.”

Stern also expressed concerns over safety, and added that the resolution appeared to directly contradict a board policy approved in July that limits the discussion of “sensitive topics” in classrooms and prohibits teachers from promoting political or ideological causes. The “Standards-Based Instructional Environment” policy states that “political, religious or socially sensitive topics must be relevant to the curriculum and presented in a factual, objective and nonpartisan manner.” It also states that teachers are expected to avoid displaying partisan materials.

“The whole school is going to commemorate this highly charged geopolitical issue ... What is more partisan material than a flag?” Stern said.

The resolution was controversial among the community, prompting both praise and criticism during public comments. Some Jewish members of the public and Jewish students spoke out in support, stating that the resolution is sorely needed amid rising antisemitism across the country.

“This is a necessary step to protect students, to protect history and to protect the truth. As a Jewish student, I’ve seen firsthand how often antisemitism is dismissed, downplayed or ignored until it’s too late,” said Jillian Samadi, president

of Beverly Hills High School’s Jewish Club.

The resolution was also supported by Beverly Hills Mayor Sharon Nazarian and Vice Mayor John Mirisch.

“This resolution makes it clear that BHUSD will protect our Jewish families, students and all community members facing discrimination, threats or attacks. As we approach the anniversary of the Oct. 7 attacks, it is vital that Beverly Hills remain vigilant and united,” a statement from Nazarian read.

However, other members of the Jewish community said the resolution promotes one religion over others and may increase antisemitism by conflating Jewish identity with the state of Israel.

“The school board and the superintendent seem to be fixated on Jewish students, as opposed to the multitudes of other ethnic identities comprising the student body of BHUSD,” resident Andrea Grossman, who is Jewish, said following the resolution’s approval. “BHUSD is diverse. What about the board’s responsibility to all of the students, not just the Jewish students? I feel the board majority has shown a disregard for these other students, when they could spend their time more productively to improve the level of education for all students in the BHUSD.”

The resolution was also condemned by the Greater Los Angeles office of the Council on American-Islamic Relations.

“By prioritizing symbolic displays of allegiance to Israel – a foreign state accused by every major international human rights organi-

zation of genocide, ethnic cleansing and forced starvation in Gaza – over the lived experiences of grieving Palestinian and Arab students, the board has chosen to make a divisive political statement and undermine the inclusive environment schools are supposed to uphold. These students will now face the daily trauma of seeing the flag of the very state killing their families flown over their schools,” CAIR-LA Executive Director Hussam Ayloush said in a statement. “To truly address antisemitism, BHUSD must invest in real education about antisemitism and all forms of bigotry, rather than equating Jewish faith and identity with the political actions of a foreign government.”

Although the resolution prompted concerns that the district would violate the Establishment Clause of the First Amendment by promoting a religion, an expert on the Constitution and freedom of speech said the policy does not violate the Constitution.

“Schools – like other government entities – can engage in their own speech, including speech expressing support for foreign countries,” said Eugene Volokh, a former UCLA professor of First Amendment law and the current Thomas M. Siebel Senior Fellow at the Hoover Institution at Stanford University. “Nor is there an Establishment Clause violation – the flag of Israel is the flag of a nation, not of a religious organization. That the nation has some religious identification doesn’t matter – many countries have an established religion, for instance. To the extent that it is seen by the resolution as representing

Jews and not just Israelis, it represents ethnic Jews, not just religious Jews. Indeed, many Israelis aren’t religious. This doesn’t tell us, of course, that the resolution is a good idea on the merits. But it’s not unconstitutional.”

The resolution requiring the display of Israeli flags was brought forward by Board Member Sigalie Sabag, who also created the board policy limiting the discussion of controversial topics in classrooms. Before Sabag was a board member, she spoke out against the discussion of the Civil Rights Movement in an elementary school music classroom, stating that the teacher “took it upon herself to teach the kids about BLM and racism.”

The district is currently being sued by two former Black teachers and a current Black assistant superintendent for allegations of racism, discrimination and harassment. Earlier this month, the district dismissed one of the plaintiffs, Jarvis Turner, the head basketball coach. His attorney Brad Gage said he was fired in retaliation for the lawsuit. Many Black students have also reported being the victims of anti-Black racism during the past school year, particularly in the aftermath of the 2024 presidential election.

Resident and former BHUSD parent Gay Abrams, who is Jewish, spoke out against the resolution and said it should address all forms of hatred instead of antisemitism alone.

“This administration did little to nothing when students, parents and the outside community were concerned – and some outraged – by the unsafe and toxic environment that existed during and after the presidential election,” Abrams said. “How will our Black, Latino and others feel about the resolution that focuses only on antisemitism and Jewish history?”

In an interview, Stern said that while she has a personal love for Israel, she worries that the resolution will risk the district’s standing and the safety of students.

“I have real and pragmatic safety concerns about what is undoubtedly a partisan symbol,” she said. “Despite many of us, myself included, believing Israel is our ancestral homeland, it doesn’t necessarily belong at a public school.”

# Facility approved at Melrose and Alta Vista

Safe Place for Youth provides interim housing and wraparound services for youth up to age 25, with the goal of transitioning them into permanent housing. The center will provide a place for youth leaving the foster system. Efforts to secure the site at Melrose and Alta Vista as interim housing date back to the tenure of former Los Angeles City Councilman Paul Koretz, and were continued by current Councilwoman Katy Yaroslavsky, 5th District.

Yaroslavsky’s spokesman Leo Daube said the new facility was designated for young people because it is partially supported by state funding for transition age at-risk youth. It is part of a larger effort to create more shelter beds and interim housing in the 5th Council District to help alleviate homelessness, he said.

“The property at 7253 Melrose has long been designated for interim housing, dating back to 2021, but in

recent years it has sat vacant and became a safety concern for the surrounding area,” Daube said. “The property owners recently completed upgrades to the site and, through council approval, extended its use with a new service provider focused on supporting transition-aged youth, including young people exiting foster care. This is a continuation of the site’s planned use, with stronger management and oversight in place to ensure it is operated responsibly and provides positive outcomes for both the youth it serves and the surrounding community.”

Safe Place for Youth CEO Erika Hartman said the facility will offer comprehensive services in a communal environment. The organization manages similar facilities in Venice, Inglewood, Mar Vista, Echo Park and Westwood, providing services to approximately 1,300 youth. Resources include case management, employment guidance and

education, health and wellness support and substance abuse counseling. Safe Place for Youth also offers a Healing Arts Program that provides a nurturing environment for creative expression through music, writing and the arts, as well as cooking and gardening. Hartman added that approximately 20% of Safe Place for Youth’s clients identify as LBBTQ+, and the new facility’s close proximity to the Los Angeles LGBT Center in Hollywood will be beneficial.

The Melrose Avenue facility will have 24-hour staff and security to mitigate any issues in the surrounding neighborhood. Hartman and Daube said staff from Safe Place for Youth and the city will meet with neighbors in the coming weeks to notify them about what to expect.

News about a new use at the site was welcomed in the neighborhood.

“We obviously hope it’s a positive step. It’s important that the city

and its contractor are going to manage the facility and make sure it’s a good fit for the neighborhood,” said Donald Duckworth, executive director of the Melrose Business Improvement District. “Like everyone else, we are looking forward to seeing this happen.”

Peter Nichols, founder of the advocacy group Melrose Action, said the previous facility was poorly managed and resulted in problems

in the community. The building closed during the pandemic and attracted squatters while vacant, he added. While supportive of the facility’s new use, Nichols said it should serve unhoused people of all ages and not just youth.

“I just wish it was more broad, but I do confidently think it’s a step in the right direction,” Nichols said. “I’m cautiously optimistic that progress is being made.”

out the city. Ambassadors also provide specialized de-escalation services to unhoused community members and can administer Narcan to people experiencing overdoses.

City staff chose Allied Universal following a request for proposal process, in which 35 responses were received. Allied Universal was selected because its proposal more closely aligned with the city’s needs, said director of community safety Danny Rivas. Allied Universal has previously provided unarmed security guard services to many government agencies, including the city and county of Los Angeles, but Rivas did not expand on how their proposal better serves West Hollywood.

“After completing interviews and an extensive selection process, Allied Universal Security Services was selected as the preferred contractor based on their strong qualifications and extensive experience providing similar service to cities and counties across California,” public safety manager Anita Shandi said.

Rivas added that he hopes there

will be a seamless transition from the services offered by Block by Block to Allied Universal.

“Allied Universal will maintain the same role and level of services that Block by Block is currently providing to the West Hollywood community,” he said. “A series of town hall meetings with the community (currently in planning stages) and monthly Public Safety Commission meetings will provide an opportunity for Allied Universal to be introduced to the community and interact with residents and businesses.”

Community members raised concerns during public comment that the vendor change would bring a more intimidating security appearance to the city, in place of Block by Block ambassadors – many of whom have become trusted community members.

“Block by Block feels more community, feels easier to approach them, feels less of an issue,” resident James Croak said. “I see people who are needing assistance or who are having issues being approached by Block by Block and I feel like it’s much less

threatening than people who are in more of a recognized security force accoutrement like Securitas and Allied, who I see as more of a stop-gap to the police.”

However, Rivas reaffirmed that the services of Allied Universal would replicate what is currently being provided by Block by Block, although uniform color will likely change. Additionally, Allied Universal will offer current Block by Block ambassadors a fast-tracked recruitment process to continue their work in West Hollywood, said Allied Universal Security Services government specialist for the southwest region Tad Garabedian, after Councilman John Erickson expressed concern with laying off numerous ambassadors.

During an Aug. 25 Public Safety Commission meeting, former Allied Universal employee Emmanuel Ares spoke about his experience working for the company. Ares said that during his time with Allied Universal, employees were often overworked, experienced pay delays and did not have adequate sensitivity training. As a result, he said turnover within the

company was high.

“I’m just hoping there is something we can do as a community, whether it’s creating a task force, subcommittee – anything that can be able to report out on how everyone is doing, maybe even an introduction meeting where we’ll be able to meet the new ambassadors to see what would be different from Block by Block,” Ares said.

Representatives from Allied Universal declined to comment on the organization’s services and employee experiences. Additionally, Shandi said there was no update regarding the amount of Block by Block staff who will be retained and the number will depend on how many employees apply to Allied Universal.

During the meeting, city staff sought feedback from the commissioners on proposed uniforms for the new ambassadors.

Commissioner George Nickle said that a change to lime green uniforms would make the ambassadors more visible to the community. He also called for more community meetings to educate the public and asked staff how many new officers will have a background in law enforcement. Shandi responded by saying there are currently five senior safety officers and the city hopes to retain the same

level of staffing during the transition.

Commissioner Tod Hallman also called for a uniform change, saying he supported the lime green or yellow and black uniforms.

“You want something that’s going to stand out when people are seeking services, when they may be panicked, or frantic or hurried. These two colors definitely stand out and are more visible,” he said.

Rivas added that the current phone number for Block by Block emergency intake, (833)WEHO-BBB, will be forwarded to the new number for Allied Universal for one year while the city works to inform the public of the new phone number, which has not yet been announced.

The agreement with Allied Universal will take effect Oct. 1 and last until June 2027. Representatives from Block by Block did not respond to a request for comment by press time.

Separately, the city of West Hollywood approved an agreement on Aug. 18 with Securitas Security Services to provide the West Hollywood Sheriff’s Station unarmed community safety officers to respond to non-emergency 911 calls in the city. The two agreements are separate and services do not intersect, Shandi said.

concerns into an updated version of the policy.

The policy will return to the board at the next meeting on Sept. 9 for clarifications on specifics.

In an interview, Stern acknowledged potential disparities in equity for access to paid tutoring

outside of the classroom. However, she questioned why the district would prohibit unpaid tutoring if a teacher is willing to offer support to students on their own time. She also expressed concerns that the policy would conflict with office hours, where

teachers answer students’ questions and offer assistance outside of the classroom.

“There has to be a delineation as to how this does not affect contractual office hours for one-on-one or maybe two-on-one unpaid teacher guidance,” Stern said.
