Beverly Hills seeks more funds for Oct. 7 memorial


■ City plans to spend \$500,000 in tax dollars

The city of Beverly Hills is seeking additional funding for the planned Oct. 7 memorial, a permanent display honoring the approximately 1,200 victims of the Hamas-led attacks in Israel on Oct. 7, 2023. The sculpture will stand adjacent

to the 9/11 Memorial Garden, which is located on the northwest corner of South Santa Monica Boulevard and Rexford Drive. The Oct. 7 memorial will be directly across the street, on the northeast corner of Burton Way and Rexford Drive. While no city funds were

Friedman urges support for redistricting

■ Congresswoman's district boundaries would slightly change

On Nov. 4, Californians will head to the polls to vote on a redistricting proposition that would greatly alter the lines for its 52 congressional representatives. The move, proposed by Gov. Gavin Newsom and moved forward by the state's

Assembly and Senate, is a direct response to an effort in Texas that could eliminate several seats currently held by Democrats.

Opponents to Texas' redistricting call it a blatant attempt by Republicans to maintain control of Congress after midterms. Newsom had threatened to make a similar, sweeping move in California, prior to the Texas state legislature's approval of its measure last month, and he made good on the promise immediately. The opposition to

Leaders decry Supreme Court ICE ruling

■ Federal raids will continue in Los Angeles

A Sept. 8 ruling by the United States Supreme Court that cleared the way for federal immigration raids to continue in Los Angeles renewed fear in immigrant communities and was met with condemnation by city and county leaders.

The U.S. Supreme Court voted 6-3 on Sept. 8 to overturn a lower court ruling that temporarily blocked immigration raids in Los Angeles. Federal district court judge Maame E. Frimpong had ruled that agents were using unlawful tactics to detain people, including targeting people based on race, language and job description, which she said violates the Constitution. Following the Supreme Court ruling, the Trump administration announced that the immigration arrests will continue in Los Angeles. On Sept. 9, agents arrested two men during a traffic stop in the San Fernando Valley that was captured on video and

widely broadcast by the media.

Federal agents also recently targeted immigrants in Hollywood at the Home Depot store on Sunset Boulevard. A spokesman for Los Angeles City Councilman Hugo Soto-Martinez, 13th District, said

four people were taken into custody by federal agents at the Home Depot on Sept. 7, adding that raids have occurred outside the store multiple times since June. The councilman decried the



Body found in car trunk remains a mystery**■ Vehicle linked to singer from Texas**

More information has surfaced in an investigation into human remains found in the trunk of a Tesla registered to singer-songwriter D4vd on Sept. 8 in a Hollywood impound lot, but many details of the case remain a mystery.

The body was discovered after employees at Hollywood Tow at 1015 N. Mansfield Ave. smelled a foul odor coming from the vehicle and called police around 12:20 p.m., Los Angeles Police Department spokesman Kevin Terzes said. The Tesla was brought to the lot on Sept. 5 after the Los Angeles Department of Transportation determined it was abandoned and ordered it to be towed from a street in the Hollywood Hills, he added. The Tesla was reportedly parked in the same location for five days before it was reported to the city. Police have not divulged the location where the vehicle was abandoned.

Terzes said the case is currently being investigated by the LAPD's Robbery-Homicide

Division and the Los Angeles County Department of Medical Examiner, which is working to determine cause of death. The medical examiner determined the human remains belong to a woman, but due to advanced decomposition, authorities have not yet been able to determine the woman's age or ethnicity. A preliminary report from the Department of Medical Examiner stated the woman was approximately 5 feet 1 inches tall, weighed 71 pounds and had wavy black hair. She was wearing a tube top, black leggings and jewelry consisting of a yellow metal stud earring and a yellow metal chain bracelet. The woman also had a tattoo that read "Shhh..." on her right index finger.

Authorities determined the car, which has Texas license plates, is registered to David Anthony Burke, known by the stage name D4vd. Police contacted Burke, who is currently on tour in the Midwest, and he is cooperating with investigators. According to media reports, Burke is from Texas and owns multiple vehicles that are frequently used by friends and associates.

BHUSD Board issued cease and desist letter

■ Parent alleges board violated Brown Act amid turmoil

Attorney Daniel Lifschitz threatened litigation against the Beverly Hills Unified School District Board of Education and issued a cease and desist letter to its members on

Sept. 9, alleging violations of the Brown Act, which ensures transparency in public meetings. The cease and desist letter comes amid turmoil over a resolution that would have required the display of the flag of Israel on school campuses that was quickly reversed following safety threats.

Lifschitz, who is a parent of a BHUSD student, accused the board of violating California Government

Code 54954.3, which guarantees the right to public comment on each agenda item voted on by a government entity. The code states that a public comment period is not required for an agenda item that has already been heard, however, it requires that the school board must provide a new opportunity for public comment if an agenda item has been substantially changed.

“Over the past few months, the board has repeatedly violated the public comment obligation by taking public comment on agenda items at the start of meetings, only to then substantially change and pass those items within the space of the same meeting, robbing the public of any opportunity to address what the board actually votes on once its marathon redlining sessions conclude,” Lifschitz said. “This includes the Standards-Based Instructional Environment resolution on July 16, the antisemitism resolution on Aug. 26 and the flag ban resolution on Aug. 29.”

Lifschitz said that Board President Rachelle Marcus and Amanda Stern have objected to the alleged violations, and that Board Vice President Judith Manouchehri, Sigalie Sabag and Russell Stuart have “embraced them with open arms.”

The cease and desist letter provides the board 30 days to commit to following the guidelines of public comment, Lifschitz said. He added that the commitment must be approved during an open session meeting.

mitted,” Marcus said.

California Government Code 54954.3 states that “the legislative body of a local agency shall not prohibit public criticism of the policies, procedures, programs or services of the agency, or of the acts or omissions of the legislative body.”

The school district has been the subject of increased public outcry and controversy for the past year. In April, former fashion design teacher Bella Ivory and former basketball coach Jarvis Turner sued the district, alleging anti-Black racism and discrimination. On Sept. 8, Los Angeles Superior Court Judge Brock T. Hammond

ruled that the two plaintiffs can move forward with one trial, rejecting the BHUSD’s request for the allegations to be presented as two separate cases. The next hearing in the case is scheduled for Dec. 12.

WeHo begins work on off-leash dog area at Plummer Park

The city of West Hollywood will begin construction of a new dog park at Plummer Park on Monday, Sept. 15.

The project is estimated to be complete in the first quarter of 2026. The work will not impact the Helen Albert Certified Farmers’ Market.

City staff will post construction notices in advance at the location of the dog park, which is east of Vista Street and west of the tennis and pickleball courts. The work may cause temporary inconveniences. Park patrons are advised to plan accordingly.

The city is creating the new dog park at Plummer Park with the health and safety of the community’s four-legged friends in mind. The dog park will offer an off-leash area divided into separate play areas for small dogs and

large dogs. The dog park will be enclosed by a fence, and the small and large dog play areas will be separated by a durable barrier. The fence will feature panels with playful and artistic designs at key locations such as entrances and exits.

Artificial turf manufactured without PFAS (per- and polyfluoroalkyl substances) will be installed without infill. The dog area will also include shade sails. Lighting will be installed along the perimeter for nighttime visibility and to highlight the panels.

The city will also construct a new, fully accessible sloped walkway to the tennis courts entrance along Vista Street. Plummer Park is located at 7377 Santa Monica Blvd. For information, email sestrada@weho.org or visit weho.org.

Postal worker sentenced for stealing checks, credit cards

■ One stolen check was valued at \$7.3 million

A former United States Postal Service letter carrier who worked at the Bicentennial Post Office at 7610 Beverly Blvd. was sentenced to five-and-a-half years in federal prison on Sept. 8 for stealing checks, credit cards and debit cards from the mail.

Rashad Deon Stolden, 34, of Huntington Beach, pleaded guilty on April 14 to one count of conspiracy to commit bank fraud. United States District Judge R. Gary Klausner sentenced Stolden to prison and ordered him to pay \$1.6 million in restitution to banks that were defrauded.

Prosecutors said Stolden stole high-value checks and credit cards, as well as debit cards from the California Employment Development Department for people receiving unemployment insurance. The thefts occurred when Stolden worked at the Bicentennial Post Office from 2020 through August 2024, according to the criminal complaint. Stolden sold the checks, credit cards and debit cards for a fraction of their value to friends and co-conspirators, who created

fake IDs using counterfeit documents and cashed the checks, authorities said. Bank of America, City National Bank, Truist Bank and the California Employment Development Department were among the victims, according to the United States Attorney's Office.

One of the highest value thefts occurred in June 2022 when Stolden stole a \$7.3 million U.S. Treasury check and sold it to a co-conspirator, who deposited it in a bank in Tennessee and withdrew more than \$1 million before the fraud was discovered, authorities said. According to court documents in the case, investigators accessed text messages from Stolden in which he discussed selling the checks. In other messages, he discussed spending tens of thousands of dollars on hotels, authorities said in court documents.

Multiple federal agencies investigated the thefts including the United States Postal Service Office of Inspector General, United States Postal Inspection Service, U.S. Department of Treasury and U.S. Customs and Border Protection.

Break-in reported at Beverly Hills High School

A break-in occurred on Beverly Hills High School's campus at approximately 3:24 a.m. on Sept. 2, according to Beverly Hills Unified School District Superintendent Dr. Alex Cherniss.



A man hopped a fence along the alley on Heath Avenue on Sept. 2, according to the BHPD.

In a message to the BHHS community, Cherniss said a student's bicycle that was left on campus over Labor Day Weekend was stolen.

Beverly Hills Police Department Sgt. Audra Alatorre said a male suspect hopped a fence along the alley on Heath Avenue and entered the campus but did not enter any school buildings. The suspect was described as a man approximately 25-35 years old. A blue Schwinn adult mountain bike was reported stolen. No arrests related to the crime have been made as of Sept. 9.

"While this incident happened during non-school hours, we know how unsettling it can feel to hear that someone unlawfully accessed our campus. We take this incident seriously, and not just because something was stolen, but because the safety and security of our students and staff remain our top priority," Cherniss said.

He added that the district is working closely with the BHPD, which is currently investigating the

Collisions on Sunset renew calls for safer streets

■ Two crashes occur within two days

A vehicle struck a pedestrian on Sunset Boulevard near the Sherbourne Drive intersection on Sept. 7 around 8:07 p.m. The driver remained at the scene and the victim was transported to the hospital. Lt. Ashley Turner of the West Hollywood Sheriff's Station said, but did not provide further details on the condition of the victim.

A separate vehicle collision occurred Sept. 8 around 9:15 p.m. on Sunset Boulevard near the Sweetzer Ave intersection when a white Mercedes SUV lost control and struck multiple parked vehicles, according to West Hollywood resident Brodie John Gallant who arrived at the scene shortly after the collision. Gallant added that he did not believe anyone suffered injuries from the collision but deputies from the West Hollywood Sheriff's Station did not provide further information regarding the collision.

The incidents come amid calls to improve pedestrian and cyclist safety in West Hollywood on Fountain Avenue – where multiple traffic incidents have occurred in recent



months, including a July hit-and-run that claimed the life of 27-year-old cyclist Blake Ackerman.

"My heart goes out to the individual injured in Sunday night's collision, and I hope for their recovery," said West Hollywood City Councilman John Erickson. "This is a painful reminder that our streets must be safer for everyone. That's why West Hollywood has enacted reforms like safer crosswalks and signal upgrades, and why I continue

to push for new tools like speed cameras and other deterrents. Vision Zero is not just a policy – it's a commitment to saving lives, and we will keep fighting to make sure no one is put in harm's way simply crossing the street in our city."

The West Hollywood City Council is scheduled to vote on Phase 1 of the Fountain Avenue Streetscape Plan, which includes reducing travel lanes from four to two and implementing a protected bike lane, on Sept. 15.

West Hollywood parents charged with child cruelty

■ Couple is jailed pending upcoming court hearings

Two West Hollywood parents were arrested in late August for allegedly abusing their 5-year-old child.

Cody Jefferis, 33, and April Joy Cordova, 30, were charged with two felony counts, including child cruelty and inflicting corporal injury to a child, and are currently being held in jail.

The 5-year-old girl was found wandering alone around 11 a.m. on Aug. 28 and asking neighbors for food on Orange Grove Avenue in West Hollywood, according to media reports. The girl showed signs of

abuse and bodily harm. Deputies from the West Hollywood Sheriff's Station were called to the scene, identified where her parents lived with the help of neighbors and went to the residence. Deputies then identified Jefferis as the girl's father and arrested him. The child was transported to a hospital, where she received medical care, according to the report. There is no information regarding the status or location of the child. Cordova, the girl's mother, was later arrested on Aug. 30.

Jefferis pleaded not guilty and remains in custody on \$75,000 bail. During court proceedings, an attorney for Jefferis alleged that Cordova was responsible for the girl's injuries. Jefferis is scheduled to appear for a preliminary hearing on Oct. 2.

Cordova's arraignment was originally scheduled for Sept. 2 but was



West Hollywood provides affordable housing update

■ Projects on Fairfax, Detroit and Wetherly make progress

Affordable housing is on the move in West Hollywood. One affordable housing project at 1201 N. Detroit St., named Lexington Gardens, has been steadily under construction and is currently accepting applicants until Sept. 30, with an opening scheduled for December. The project will offer 47 affordable housing units, and one manager unit. Tenants will be selected based on a lottery that is scheduled for Oct. 7. Residents will be split into three categories based on income. The first category will pay 30% of adjusted income for rent, the second category will pay \$1,053 and the third will pay \$1,621. All units are ADA accessible. Interested residents can apply at eahousing.org/lexington-garden.

A co-living development is planned at 1301 Fairfax Ave. where buildings were recently demolished due to code compliance, according to Sheri Lunn, public information officer for the city of West Hollywood. The development was approved in 2021 and will include 73 co-living bedrooms and 32 parking spaces on the northwest corner of Fairfax and Fountain avenues. The project was opposed by neighboring property owners at the time of approval, who alleged the development would cause traffic conges-

tion and parking issues in the area. The original architect for the project, Levin-Nariño Architects, Inc., is no longer involved and new architect has not been approved. No further information is available regarding construction for the development at this time, Lunn said.

Additionally, the project applicants for an affordable housing development at 910-916 Wetherly Drive are finishing the plan check review to obtain building permits. The project was approved in 2024 as a seven-story, 89-unit building that would contain 100% affordable housing, but there is no construction scheduled yet for the development. The building is located next to the First Baptist Church of Beverly Hills, and as part of the development deal, two units would be reserved for pastoral staff with rent to be paid by the church. The West Hollywood City Council denied an appeal against the project in 2024 that questioned the size and density of the building and the construction's environmental impacts.

West Hollywood Mayor Chelsea Byers said the developments are necessary to meet the region's need for more affordable housing.

"Every new home built in West Hollywood is a victory because it means more people have access to the resources and quality of life available in this city," she said. "It's particularly exciting to see these designated affordable housing projects nearing completion because they are often the most difficult to

accomplish and they are highly needed in this region. We know the region as a whole needs nearly 600,000 new affordable homes just to meet the current need and while West Hollywood cannot accomplish that on its own, these new apartment buildings remind us that each plot of land holds a tremendous opportunity to meet the community's needs and we must take these opportunities seriously."

Councilman John Erickson also said that the city needs to do everything it can to add more affordable housing.

"Projects like 1301 Fairfax and 1201 N. Detroit represent the best of what West Hollywood stands for: building real, affordable homes for the people who need them most," he said. "1301 Fairfax is on its way after several frivolous lawsuits tried to deter it, and Lexington Gardens at 1201 N. Detroit is nearly ready to welcome residents home, and I'm proud to have supported both of these critical projects. These aren't just buildings – they are opportunities for people to thrive and stay rooted in our community."

Erickson added that the developments are needed to meet the city's Housing Element and represent West Hollywood values of equity and inclusion. All California cities are required to meet state-mandated housing goals, which are reassessed every eight years. The current update to the city of West Hollywood's plan was adopted in February 2023 and covers the period from 2021-29.





Can Dogs Smell Time? The Science Behind a Dog's Mysterious Nose

We all know dogs have remarkable noses – but could they actually smell time? While it sounds like science fiction, emerging research suggests they can sense the passage of time by following changes in scent.

A Superpowered Nose

Humans have about 5 million scent receptors. Dogs? Up to 300 million. Their olfactory bulbs – the brain's scent processors – are 40 times larger than ours in relative size. This gives them abilities that border on the magical: detecting certain cancers, predicting seizures, and identifying explosives. But it may also allow them to "read" the clock without ever looking at one.

Scent as a Clock

Every person, place, and object leaves behind a unique odor fingerprint. As hours pass, those molecules fade, drift, and change with air currents and temperature. Scientists believe dogs interpret these scent gradients like markers on an invisible timeline. This may explain why dogs know when their owner is about to come home. Not because of the ticking of a clock, but because your morning scent trail has faded to a predictable strength by evening. In other words, they smell your absence aging.

The Science in Action

Canine cognition researcher Alexandra Horowitz has suggested that dogs "see" time through smell. A dog may detect not only that you were in a room, but how long ago you were there. They may also anticipate events – like dinner – because the scent of food storage intensifies at certain times of day.

Why It Matters for Pet Parents

Understanding dogs' scent-based sense of time helps us interpret their behavior. That restless pacing near dinnertime? Their nose is telling them it's late. Barking at the window before you arrive home? They may be responding to invisible odor cues in the environment.

How to Support Your Dog's Inner Timekeeper

• **Stick to routines:** Consistent walk and meal schedules align with their scent expectations.

• **Offer enrichment:** Snuffle mats and puzzle feeders let them engage their powerful olfactory sense.

• **See your vet:** Sudden changes in pacing, restlessness, or awareness can sometimes signal medical or cognitive issues.

We know that dogs live in a world of scent first, sight and sound second. By tuning into how they experience time, we can create calmer homes – and strengthen the bond we share with our four-legged family members.

WeHo mail thefts reflect larger problem

■ Officials report drastic increase in mail theft

A series of mail thefts in West Hollywood reflect a larger national problem, according to Frank Albergo, the national president of the Postal Police Officers Association.

Albergo said a national upsurge in mail theft is a direct result of the U.S. Postal Service's decision in 2020 to end daily Postal Police patrols and confine officers to postal facilities.

"For 50 years, Postal Police would be deployed to hot spots, targeted police patrols to prevent mail theft, and it worked. Their own data show that Postal Police mail theft prevention patrols are the most effective tool to stop mail theft," he said.

Oliver Thornton, 32, was arrested on July 31 for four separate mail thefts at Holloway Terrace at 8530 Holloway Drive. He was charged with four felony counts of residential burglary. Thornton posted bail and was released from custody on Aug. 11, but did not appear for a court hearing scheduled for Sept. 8. A warrant was issued for his arrest. A separate individual disguised in a U.S. Postal Service uniform who stole mail from the same building has still not been apprehended, according to the building's HOA president who declined to be named, citing safety concerns.

Thornton was arrested while in possession of a master mailbox key and the second suspect is also believed to possess a master key.

West Hollywood Sheriff's Station Captain Fanny Lapkin said investigators are working with the office of Los Angeles County Supervisor Lindsey Horvath, 3rd District, and U.S. Sen. Adam Schiff (D-Calif.) to collaborate with the U.S. Postal Service on changing master mailbox locks.

A 2024 U.S. Postal Inspection Service report stated that instances of mail theft significantly increased nationwide from 2019-24.

"Beginning around 2020, and continuing to [2024], the Postal Service has experienced a significant increase in mail theft from mail receptacles, primarily due to financially motivated crimes like check fraud," the report read. "This is evidenced by a 139% increase in reports of high-volume mail theft from mail receptacles between [2019] and [2023], with 20,574 reports in [2019] and 49,146 reports in [2023]. The significant rise in mail theft and associated financial crimes appears to be driven by

organized criminal groups who have shifted their focus towards the perpetration of low-risk, high-reward financial crimes."

Albergo said that Postal Police officers previously patrolled West Hollywood and if they were able to resume patrols, statistics predict that mail thefts would decrease by at least 50%. Instead of conducting patrols, Postal Police officers now forward calls to U.S. Postal Inspectors who investigate instances of mail theft after the incident occurs, he added.

"When you're talking about street-level crime, you don't [only] investigate it, right? Because that's stupid. What you do is you stop it," Albergo said. "So imagine if there's an explosion in shoplifting, and LAPD responds by saying, 'Well, we're going to investigate every instance of shoplifting,' but that's what the Inspection Services law enforcement model is."

However, during a July 23 congressional testimony, U.S. Postal Inspection Service's Inspector in Charge Brendan Donahue stated

that local and state law enforcement officers are better positioned to conduct neighborhood patrols than Postal Police officers.

"Given that there are over 230,000 postal delivery routes, it would not be practicable, cost-effective or even logical to patrol every route," he said.

Donahue also pointed to Project Safe Delivery, an initiative launched by the U.S. Postal Inspection Service in 2023 to combat mail theft. Through the project, the U.S. Postal Service has installed more than 23,000 high security blue collection boxes nationwide with 16,000 additional boxes scheduled to be installed.

The Postal Inspection Service also faces the challenge of lenient legal consequences for people convicted of mail theft.

"One example was a subject arrested in possession of two postal keys, who stole mail on at least eight occasions and was found with

over 3,000 pieces of stolen mail, USPS mail tubs and checks and money orders with a face value of over \$1.5 million," Donahue said. "This subject pleaded guilty to theft of mail in late 2024 and was sentenced earlier this month to six months of home detention, three years of probation and community service."

Albergo said that benching postal police officers has had devastating impacts.

"In my 31-year career, as a postal employee, I've never seen anything like this," he said. "It's like we're going back to the days of the Pony Express. That's how bad postal related crime has become."

'Jaws' bites into the Academy Museum

■ Spielberg on hand for exhibit's launch

Just when you thought it was safe to go back to the Academy Museum ... on Sept. 14, the motion picture hub is unveiling a new exhibit highlighting Hollywood's seminal blockbuster, "Jaws." On Sept. 10, the museum held a special press preview, which was backed by a full orchestra and featured an appearance by the movie's legendary filmmaker Steven Spielberg.

The film – which put then-28-year-old director on the map – was actually more than just a blockbuster. It was a phenomenon. Starring Roy Scheider as Police Chief Brody, who desperately wants to close Amity Island's beach

following a pair of vicious shark attacks but is overruled by the mayor's greed for Independence Day tourist bucks (you can guess where this is going), the movie was a massive cultural touchstone. Its unparalleled promotional campaign and merchandising tie-ins showcased how great an effect a big, bold, bombastic movie could have on society at large. Reportedly, beach attendance fell noticeably in the summer of 1975, all thanks to one cinematic predator.

In the 50 years since its release, the film's reputation has only mushroomed, in no small part due to the three sequels (of greatly diminishing quality) that followed, regular rereleases (including one raking in at the box office right now), and Universal Studios' embrace of all things "Jaws." Yes, you can still head over to the studio tour and get splashed

by the shark himself, Bruce, named for Spielberg's lawyer ... get it?

Its production history has, too, crossed into mythic legend. The long location shoot in Martha's Vineyard was rife with mishaps, including a constantly malfunctioning mechanical shark, unreliable weather and a ballooning budget.

"I thought my career was virtually over halfway through production on Jaws, because everybody was saying to me, you are never going to get hired again. This film is way over budget and way over schedule, and you are a real liability as a director, and you are not going to get hired again," Spielberg said.

The filmmaker – who would go on the helm "E.T.," "Schindler's List" and "Jurassic Park," among many, many others – said he had the "hubris" to believe that he could take a Hollywood crew on location 12 miles into the Atlantic Ocean, shoot a whole movie with a mechanical shark, and it would "go swimmingly." The movie ended up going 100 days over schedule, with a shoot that lasted 158 days total.

"But nobody wanted to quit. Nobody wanted to stop. One of the biggest questions the crew kept asking me, and every week I'd have five or six people come over to me to say, 'I have children, I have dependents. I haven't seen them. I haven't seen my family. I've been here for five months. Just give me an incentive to keep working on your movie. Give me a date, a guarantee of when you're going to wrap.' And I didn't know when we were going to wrap until two weeks before we wrapped on Martha's

Beverly Hills approves extended closure of Cañon

■ Council denies Metro request to work during holidays

The Beverly Hills City Council on Sept. 9 voted 4-1 to approve a five and a half month extension of the closure of North Cañon Drive at Wilshire Boulevard. The intersection will remain closed until March 14, 2026. Additionally, the City Council unanimously voted to deny Metro's request to work during the holiday moratorium between Thanksgiving and New Year's Day.

The intersection of North Cañon Drive and Wilshire Boulevard has been closed since 2019 due to the ongoing construction of Metro's Wilshire/Rodeo Station, which will be a stop on the D-Line extension project. The intersection was permitted to be closed until September 2025. However, on June 13, Metro requested the extension of the closure to allow further construction. According to a city staff report, the opening of North Cañon Drive before March could lead to significant traffic impacts, lane closures and additional construction that would not be needed if the intersection remains closed until March.

"Reopening the street early would result in unpredictable traffic patterns, requiring frequent changes at the Wilshire Boulevard and North Cañon Drive intersection, including lane closures and turn restrictions," the staff report stated. "Daily traffic control would be needed from Wilshire Boulevard to Dayton Way with detours, mes-

sage boards, traffic cones, and restrictions on valet and on-street parking."

Beverly Hills Public Works Director Shana Epstein said the March 14 opening date for the intersection minimizes traffic impacts and will require less lane closures.

Metro agreed to open the intersection by 7 a.m. on March 14, one day before the 98th Academy Awards. The Vanity Fair Oscars Party following the event is traditionally held at the Wallis Annenberg Center for the Performing Arts, which is located less than one mile from the intersection.

Metro has agreed to pay the city a fee of \$20,000 per day if the intersection does not open by March 14.

Beverly Hills Chamber of Commerce CEO Todd Johnson said the extension was necessary to reduce the impacts on surrounding businesses.

"We've talked to many of the stakeholders in that area and they all agree," Johnson said. "We feel that whatever we can do to help Metro move on and move forward is going to be a good thing."

Businessman and Rodeo Drive developer Dar Mahboubi said that Metro's construction has been "grossly mismanaged" and urged the city to keep the interests of residents and business owners in mind when negotiating with Metro.

"Metro, with their construction activities, have caused great pain and inconvenience to all residents of Beverly Hills and have caused irreparable interruption to the businesses located at the Beverly Hills Triangle, South Beverly Drive and Wilshire Boulevard," Mahboubi said.

The council ultimately voted 4-1 to approve the extension, with Vice Mayor John Mirisch voting against the approval.

Mirisch said the city should have asked Metro to directly compensate the businesses that have been impacted by the closure.

"It just seems like we're afraid to try and negotiate with them or even to play hardball," Mirisch said. "We can try and rationalize for ourselves why this is good, but ultimately this is much better for [Metro] and I think we should negotiate something with them that would benefit our residents, that would benefit the businesses and that would benefit the city."

Mayor Sharona Nazarian said that she hoped the city's willingness

With the new exhibition, aptly titled "Jaws: The Exhibition," this frenzied production, as well as the movie's lasting impact, are painstakingly preserved, with props, costumes, fins, interactive experiences and copious production materials.

"This exhibition is just awesome. Every room ... has the minutia of how this picture got together and proves that this motion picture industry is really, truly a collaborative art form," Spielberg said.

Of course, since the Academy Museum opened in September 2021, one of the mechanical sharks has been on display prominently, hanging high in the rafters on the fourth floor (where the new exhibition is located) adjacent to the escalators, greeting guests as they move from floor to floor. At 25-feet-long, the last remaining "Jaws" shark

to work with Metro would encourage Metro to coordinate with Beverly Hills on safety measures in the future.

"It's not an ideal situation. At the end of the day it's here and we want to be able to create transportation," Nazarian said. "My only hope is that we create the safest environment possible both on the Metro as well as the space outside of the Metro."

In addition to approving the closure extension, the city denied a request from Metro to allow work during the holiday moratorium between Nov. 27 and Jan. 1, 2025. While work within staffing yards and underground areas is permitted during the moratorium, no work on the street level in the public right-of-way is permitted.

A city staff report found that granting a waiver for work during the holiday moratorium would not

significantly reduce the overall construction schedule or expedite the station opening. While the city approved the waiver of the holiday moratorium in 2024, that approval was made with the agreement that Metro would construct a public safety center kiosk in the Wilshire/La Cienega Station. According to Epstein, Metro was not willing to agree to create another safety kiosk until the first one is complete and the impacts on safety can be measured. As a result, the council unanimously voted to deny Metro's most recent request to waive the holiday moratorium.

"When they're not giving us anything and it's not going to speed it up, it just didn't pay to waive the moratorium," Councilman Lester Friedman said.

The Wilshire/Rodeo station is scheduled to open in 2026.

West Hollywood Park mural ‘In Her Own Pattern’ celebrates women

The city of West Hollywood Arts Division installed a new temporary public artwork, “In Her Own Pattern” by Violet Danesh, on the ground floor of the West Hollywood Park five-story parking structure. The 9-foot-by-9-foot vinyl mural installation is on display through Oct. 30, 2026.

The bold, black-and-white stripes suggest both order and disruption, symbolizing how patterns, whether societal or personal, can be worn, reshaped or reclaimed. Her expression is poised yet unreadable, balanced within a space of flat planes and fractured realism. The stylized face, layered with earthy tones and sharp lines, speaks to complexity, resilience and individuality.

Violet Danesh is a multidisciplinary artist, art director, and long-time painter whose work explores identity, memory and the emotional landscapes of womanhood. With a background in graphic design and more than a decade of experience in digital and interactive design, Violet blends fine art with visual storytelling to create pieces that are both intimate and expansive. Her paintings often draw from lived experiences as an immigrant woman, using layered



Metro work stays steady around subway stations

The Los Angeles County Metropolitan Transportation Authority is continuing work at the new subway stations on the D Line extension project.

Crews are working at the stations at Wilshire/La Brea, Wilshire/Fairfax and Wilshire/La Cienega on the first segment of the project, anticipated to open at the end of 2025, and at the Beverly Drive and Century City stations on the second segment, scheduled to open in 2026. The work also includes streetscape improvements at multiple locations along Wilshire Boulevard in the Miracle Mile and in Beverly Hills between San Vicente and La Cienega boulevards.

Crews are restoring the street and sidewalks along the south side of Wilshire Boulevard between La Cienega and San Vicente boulevards. Temporary road closures may be implemented on South Hamilton and South Tower drives and a K-rail work zone remains in

place on the south side of the street. Two lanes remain open in each direction on Wilshire Boulevard between San Vicente and La Cienega boulevards.

On Saturday, Sept. 13, from 6 a.m. to 10 p.m., eastbound Wilshire Boulevard will be closed between La Cienega Boulevard and Hamilton Drive. La Cienega Boulevard will also be reduced to a single lane in each direction between Gregory Way and Clifton Way. Left turns within the Wilshire/La Cienega intersection will be intermittently restricted, with the exception of eastbound Wilshire Boulevard to northbound La Cienega Boulevard. The traffic control supports utility work in the Wilshire/La Cienega intersection.

From Friday, Sept. 27, at 8 p.m. through Saturday, Sept. 28, at 10 p.m., eastbound Wilshire Boulevard will be reduced to two lanes between Le Doux Road and Gale Drive, westbound Wilshire Boulevard will be reduced to one

lane from Gale Drive to Le Doux Road; and northbound La Cienega Boulevard will be reduced to a single lane from Wilshire Boulevard to a location 500 feet north of the intersection. The traffic control supports ongoing sewer maintenance at the Wilshire/La Cienega intersection.

At the Beverly Drive Station, ongoing construction continues at and around the subway station site. Work in the AKA alley between Cañon and Crescent drive is progressing, with permanent sewer, water installation and utility relocation work ongoing throughout September. Crews are also decommissioning geotechnical instruments in the area. On Sept. 11-12 from 8:15 p.m.-7 a.m., westbound Wilshire Boulevard will be reduced to one lane between Maple and Palm drives. Also, the south sidewalk on Wilshire Boulevard between Cañon and Crescent drive is closed through Sept. 26 for underground construction.



Farther west, preparations are underway to remove deck panels near the Century City Station. The work is scheduled to begin in September and is expected to last approximately two months. Traffic control measures will be implemented in five phases, progressing from east to west. Following deck removal, traffic

control measures will be reestablished on Constellation Boulevard to support further construction activities.



Taiwan's 23 million voices left out of the U.N.

The upcoming United Nations General Assembly is once again overshadowed by the ongoing misuse of UNGA Resolution 2758. For decades, this resolution has been distorted to exclude Taiwan from the U.N. system, even though the text makes no mention of Taiwan. In fact, the resolution only addresses the question of China's representation in the U.N. It does not determine Taiwan's status, nor does it endorse China's so called "one China principle."

This misrepresentation has had serious consequences. Taiwan's 23 million people are denied participation in the U.N. system, including critical platforms for global health, sustainable development and security. Such exclusion undermines the very principles of inclusivity and equality that the U.N. Charter was built upon.

The situation is more urgent than ever. China continues to pressure U.N. member states into accepting its false narrative, threatening peace and stability across the Taiwan Strait and the broader

Indo-Pacific. This year's U.N. theme, "Better Together: 80 years and more for peace, development and human rights," rings hollow if Taiwan remains shut out.

Taiwan has consistently shown that it is a responsible global partner, contributing to humanitarian aid, public health and sustainable development. Excluding Taiwan not only violates the rights of its 23 million people but also weakens the world's collective capacity to address shared challenges.

The U.N. system was established to serve all humanity, not the political interests of a single power. It is time to end this misrepresentation and allow Taiwan to take its rightful place in the international community.

Fountain Avenue bike lanes don't make sense

One thing the planners and advocates don't seem to under-

stand is that traffic is like standing water on a roof – it will always find a way to get through. This is especially true in the days of Waze and real-time enabled automobile GPS systems.

The proposed bicycle lanes on Fountain Avenue make no sense whatsoever. Why not? Because Fountain Avenue is located downhill from Sunset Boulevard and uphill from Santa Monica Boulevard. Almost all cyclists, especially commuters, avoid hills.

Yes, installing protected bike lanes will slow traffic, but Fountain has been an important cut-through street to and through Hollywood since long before Johnny Carson's show with the famous Bette Davis advice to young starlets – "Take Fountain." The traffic will merely find somewhere else to cut through between Sunset and Santa Monica, through West Hollywood. The apps will tell drivers where to go.

Building protected traffic lanes along relatively flat Santa Monica Boulevard makes more sense, as does completing the "bike path to nowhere" that runs a few blocks on Beverly Boulevard from Santa Monica Boulevard to Doheny

Drive. Limiting overbuilding along Sunset Boulevard makes even more sense.

Installing bike lanes on Fountain makes no sense. Whatsoever.

And all to make room for a plaza that no one asked for and no one wants. Additional security to keep the unhouse from occupying the plaza would be unnecessary if the plaza was never created in the first place.

We love our park and use it often. It is an oasis of calm and peace in the middle of a troubling world. We would like to preserve what is special and lovely about it as much as possible.



LACMA acquires pivotal work by Francis Bacon

The Los Angeles County Museum of Art announced on Sept. 9 that 20th-century artist Francis Bacon's triptych "Three Studies of Lucian Freud" (1969) has been gifted to the museum as a bequest of the late philanthropist Elaine Wynn, who served as co-chair of LACMA's board of trustees. The first work by Bacon to enter LACMA's collection, "Three Studies of Lucian Freud" is the only painting by Bacon in a Los Angeles public collection, as well as the only triptych by the artist in a California public collection.

"Elaine was among the most generous and supportive leaders in LACMA's entire history," LACMA CEO and Wallis Annenberg Director Michael Govan said. "She was our biggest champion and was as passionate about accessibility to art as she was about works of art. Thanks to Elaine's incredible generosity, Bacon's masterpiece will belong to LACMA and the public."

One of the most important and celebrated painters of the last century, Irish-born British figurative

painter Francis Bacon (1909-1992) was known for strident, distorted images of crucifixions, self-portraits, portraits of popes and portraits of a few close friends. Bacon and British painter Lucian Freud were intimate friends and artistic rivals for a quarter of a century. "Three Studies of Lucian Freud" is a towering life-size portrait of Freud, painted in Bacon's celebrated triptych format at the height of their relationship. One of two triptychs Bacon painted of the fellow artist, "Three Studies of Lucian

Freud" was exhibited shortly after it was completed, and then the panels were separated for 15 years before being reunited in 1999. The painting has not been seen publicly since being acquired by Wynn at auction in 2013.

The triptych will be included in the inaugural installation of the David Geffen Galleries, which will open in April 2026 and will house LACMA's permanent collection.



'Caught Stealing' welcomes Aronofsky to commercial filmmaking

Wow, the pickings are slim right now. Luckily, acclaimed auteur Darren Aronofsky saves the day with something unlike anything in his resume: a film designed for a broad audience that doesn't make us all feel insanely depressed. "Caught Stealing" is fun, forgettable fare, but as the latest Aronofsky feature, it's unprecedented.

Some elements feel familiar to his other works. It's 1998, the Lower East Side of New York. Bartender Hank (Austin Butler) is charming and knows how to have a

good time, especially with Yvonne (Zoe Kravitz). Just ignore that he jolts awake each day, reliving a past trauma.

Things go south after his neighbor Russ (Matt Smith) leaves town. Various unsavory fellows keep showing up, assuming Hank knows more than he does about Russ' whereabouts and business ventures. Each denial meets another beating. He's soon on the run from two criminal factions and police with Russ' cat in tow.

We know this film. We see it every couple years. But not from



"Grounded" highlights the museum's holdings of works by local artists as well as Latino and Chicano artists, and its burgeoning collection of works by Indigenous artists, spanning from the late 1970s to today. Nearly half of the featured artworks are major recent acquisitions, including pieces never-before

seen by the public. The exhibition also includes examples from the Mohn Art Collective: Hammer, LACMA, MOCA (MAC3), a collection of works by Los Angeles-based artists jointly owned and managed by the three institutions.

"Grounded" is loosely organized into sections that encourage visitors to discover overlapping ideas, strategies and histories. The exhibition brings works together by artistic approach such as performance or engagement with spiritual or political action; by material, where artists integrate technology with ancient craft; or through theme.

A dominant similarity among many works in "Grounded" is the upcycling of materials. Artists transform organic matter, everyday objects and urban detritus to comment on overconsumption while exploring the potential for the materials to take on new life.

Aronofsky. This is the man behind "Requiem for a Dream," "The Wrestler," "Black Swan," "Mother" and most recently "The Whale." How does he go from intimate, gritty, occasionally disturbing character pieces to something so commercial?

Mind you, "Caught Stealing," based on Charlie Huston's 2004 novel, is nowhere near a bad film. As far as this type of film goes, it's good, thanks to Aronofsky and Huston's screenplay. But it shares more in common with a Guy Ritchie heist film or the likes of "Lucky Number Slevin" than anything more avant-garde that Aronofsky champions.

That must be the angle. Take Aronofsky's affinity for character studies and make it more accessible with something more plot driven. After all, Aronofsky was considered to helm a "Batman" flick before Chris Nolan landed the gig in the mid-2000s. And Aronofsky tried his hand at blockbuster filmmaking with "Noah," which surprisingly turned a profit.

Who knows if "Caught Stealing" will lead to other high-profile productions or simply be a hiccup in Aronofsky's long line of tragic stories about folks who can't seem to

make good life choices. Whatever happens, he's still a darling amongst actors, and for good reason.

Butler's performance is wonderful. The California native still can't shake that Southern drawl he mastered for 2022's "Elvis" — though he tries something hilariously new for one scene. The rest of the main cast is pretty stacked: Zoe Kravitz, Matt Smith, Regina King, Vincent D'Onofrio, Liev Schreiber, Bad Bunny and Carol Kane for a minute. It might be a heist adventure, but each star receives a few good on-screen moments.

Just don't expect the film that was advertised. Trailers promised a lot more comedy along the way. Not so much. The label dark comedy also doesn't help. A few attempts at humor try to seep in, but "Caught Stealing" is mostly dark. Add a tragic backstory to more tragedy

along the way. That is the Aronofsky way. But there's more hope come the conclusion. That's significant compared to more than half his films that end so, so, so, so, so sadly.

But reaching that not-entirely-hopeless point still dips into Aronofsky's bag of tricks. There's all the standard heist bits — shootouts, torture, chases — along with a dose of realism. Not necessarily more violence, just a growing body count along the way that'll remind spectators that crime ain't all laughs (or really any in this film).

"Caught Stealing" is a perfectly enjoyable romp through the previous century, coinciding with the release of Aronofsky's first feature "Pi" and some splendid throwbacks, like Giuliani's influence on the Big Apple or Smith going full punk rocker, complete with a dyed mohawk and studded accents.

Griffith Observatory broadcasts rare lunar event on Sept. 13-14

The Griffith Observatory is hosting an online broadcast of the major standstill northern moonrise from Chimney Rock, Colo. on Saturday, Sept. 13, from 9:30-10:50 p.m., and Sunday, Sept. 14 from 10:30-11:50 p.m., weather permitting. The entire live U.S. Forest Service program at Chimney Rock will be presented in the broadcast, which will be available on Griffith Observatory's YouTube Channel at [youtube.com/user/griffithobservatory](https://www.youtube.com/user/griffithobservatory).

The moon is currently doing something it hasn't done for more than 18 years – its orbit around the Earth is tilted at the greatest angle from the path of the sun. The circumstance known as the major lunar standstill is taking place through the end of 2025. The Griffith Observatory will broad-

cast the phenomenon on Sept. 13-14 live from Chimney Rock National Monument in southwest Colorado, where the view of the moon rising between two monumental rock pillars is especially striking. Because the mountaintop can accommodate only a small number of eyewitnesses, the United States Forest Service, in consultation with tribal partners, the Griffith Observatory and Griffith Observatory Foundation, is broadcasting the northernmost moonrises from the summit at Chimney Rock.

Marciano Art Foundation announces two special exhibitions

Marciano Art Foundation announced the fall 2025 exhibitions, "Corita Kent: The Sorcery of Images," opening Sept. 26, and "JOHN GIORNO: NO NOSTALGIA," opening Oct. 25.

Corita Kent (1918-1986) was an artist, teacher and activist who uniquely combined her passions for faith and politics in an exuberant and joyfully creative practice. As a Catholic nun in Los Angeles's Immaculate Heart of Mary order and an influential art teacher at Immaculate Heart College from 1947 to 1968, Corita (as she was known) gained international recognition for her signature serigraphs (silk-screen prints) that innovatively brought together elements of popular culture with messages of love, faith and politics.

"Corita Kent: The Sorcery of Images" focuses on a little seen part of Corita's artistic practice: her archive of over fifteen thousand 35mm slides that she and her cohorts took between 1955 and 1968 while she was a beloved teacher in the art department

at Immaculate Heart College. Collecting fragments of the world with her camera for reuse at a later date, her eye documented the contemporary Los Angeles urban landscape.

Marciano Art Foundation will also host Corita Art Center's annual Corita Day on Nov. 22.

"Corita Kent: The Sorcery of Images" is curated by MAF Director Hanneke Skerath and independent writer and curator Douglas Fogle for Marciano Art Foundation, in collaboration with Corita Art Center.

MAF is thrilled to reopen the second floor Window Gallery on Oct. 25 with an exhibition devoted to the late poet, artist and activist John Giorno (1936-2019). Known for taking poetry beyond the printed page into the realms of performance, sound installation and painting, Giorno stated that he was "determined to make poetry a razor blade cutting through the ego of America's karma." MAF's exhibition will bring together a select group of Giorno's

work ranging from early prints to his black-and-white text and rainbow paintings. Also on view will be a selection of materials from Giorno's archive showing how he pieced together his poems, while demonstrating the public and private friendships that made him a force and an essential voice in the New York art scene since the 1960s. Giorno's acclaimed work "DIAL-A-POEM" (first launched in 1969) will also be featured. Visitors will have on-demand, 24-hour access to over 250 recordings of poems read by 132 poets, artists, musicians and activists – all at one's fingertips and the dial of a phone number.

"JOHN GIORNO: NO NOSTALGIA" is curated by MAF Director Hanneke Skerath and writer and critic Carlos Valladares for Marciano Art Foundation in collaboration with Giorno Poetry Systems.

A slate of associated programs tied to both exhibitions will be announced later, and tickets for "Corita Kent: The Sorcery of Images" are available now.



Art Deco building has long history on the Miracle Mile



The Dominguez-Wilshire building in the 5400 block of Wilshire Boulevard was undergoing a major renovation in this photograph in the Sept. 2, 1998, issue of the Beverly Press and Park Labrea News. Designed by architects Morgan, Walls and Clements, the building opened in 1931 and was the second Art Deco office tower on the Miracle Mile after the Wilshire Tower, which opened in 1929 at 5514 Wilshire Blvd., according to the Los Angeles Conservancy. The lower floors of the Dominguez-Wilshire building once housed the Myer Siegel department store, which specialized in women's clothing. Los Angeles City Councilwoman Katy Yaroslavsky, 5th District, recently moved her field office into a ground-floor space at 5416 Wilshire Blvd. in the Dominguez-Wilshire building and invites the community to a grand opening celebration on Sunday, Sept. 14, from 1-4 p.m. For information and to RSVP, visit tinyurl.com/CD5Open.

used to construct the 9/11 Memorial Garden – as it was funded entirely through private donations – the Oct. 7 will be partly funded by tax dollars, as the city has already allocated \$500,000 of city funds to construct the project. However, the city expects the project to cost approximately \$1.5 million, and is creating a fundraising campaign to seek donations from the public.

The memorial will be titled “Forty Steps to the Sky: A Memorial of Light and Memory” and it will feature a 23-foot sculpture resembling a staircase surrounded by a small pavilion, which will be illuminated at night. The project was designed by Archillusion Design.

“The spiral form of the memorial is a metaphor for the Jewish people’s ancient relationship with

ascent, both physical and spiritual. The staircase recalls Jacob’s ladder, a sacred bridge between Earth and heaven, body and soul,” the project description reads. “At its base lies a circular basin designed as a calendar. Twelve smooth steel plates divide the foundation, like the 12 months of the year. The structure’s height, 23 feet, marks the year of the tragedy. The steps above represent weeks, aligned with the months below. The first 40 flawless steps mark the passage of time to the month of October. Then, beginning on Oct. 7, the form fractures. Order gives way to disruption. The steps warp and twist, transforming into the shape of a light, its torn edges evoking the shattering of commandments and the unraveling of peace.”

In a study session on Sept. 9, the City Council considered the

specifics of a fundraising campaign to raise approximately \$1 million for the project.

The council determined that the memorial should recognize donors by including their names engraved on the back wall of the memorial, with different font sizes based on donation level.

The proposition to create a fundraising campaign for the memorial received one public comment.

“Unfortunately, today I see it foremost as a memorial to genocide, and I think the city should have no part in creating it,” resident Mark Elliot said. “Having said that though, I believe that anyone who supports this project, even down to those \$10 contributors, should be acknowledged with engraved plaques at the memorial. The biggest donor names should of

course be engraved in big, bold letters and placed right below the names of the five council members responsible for it.”

Elliot also suggested that the

memorial should include an acknowledgement of the approximately 64,000 Palestinians who have been killed in Gaza since the war began.

Raids continue to generate fear, anger

arrests and the Supreme Court ruling.

“This is a dangerous escalation on our path to authoritarianism. With this ruling, the Supreme Court is allowing masked federal agents to take anyone they want with no due process or justification needed,” Soto-Martinez said. “We will never stop fighting for the well-being of all Angelenos, regardless of where you come from or your documentation status. If you see a raid, stay calm, call the Rapid Response hotline at (888)624-4752, and if it’s safe, record from a distance and stay there to help document who was taken.”

The councilman’s spokesman Nick Barnes Batista said the council office has coordinated training and the deployment of volunteers to locations such as Home Depot to warn people when they see agents approaching and to document ICE activity. He added that the council office has held food and resource distribution fairs where essential goods were delivered to more than 250 families.

While the Supreme Court ruling renewed fear about detentions and arrests, it did not deter a handful of men from seeking work at the Hollywood Home Depot on Sept. 9.

“I have to work to support my family,” said a man in the parking lot who declined to provide his name. “I don’t have a choice.”

In response to the ruling, city and county leaders are looking at next steps.

“I want the entire nation to hear me when I say this isn’t just an attack on the people of Los Angeles, this is an attack on every person in every city in this country. [The] ruling is not only dangerous – it’s un-American and threatens the fabric of personal freedom in the United States of America,” Los Angeles Mayor Karen Bass said in a statement. “This decision will lead to more working families being torn apart and fear of the very institutions meant to protect – not persecute – our people. Let me be clear: we will not allow the White House, nor the Supreme Court, to

divide us. And to all Angelenos, I will never stop fighting for your rights, your dignity and your safety, despite this administration’s efforts to threaten them.”

Los Angeles City Attorney Hydee Feldstein Soto also denounced the raids and reaffirmed that she will continue to seek legal remedies to protect residents. On Sept. 10, Feldstein Soto announced that her office – with the county of Los Angeles and the cities of West Hollywood, Chicago, New York, Baltimore and Boston – filed an amicus brief supporting Gov. Newsom in an appeal pending before the Ninth Circuit over the federalization of the National Guard, which was deployed to L.A. in June as part of the federal raids.

“This decision weakens Fourth Amendment protections against unreasonable searches and seizures,” Feldstein Soto said. “The lower court found that reasonable suspicion cannot rest on these discriminatory factors, yet the majority has endorsed practices that raise serious constitutional concerns.”

Los Angeles County Supervisor Hilda Solis, 1st District, called the raids a violation of basic rights.

“[The] Supreme Court ruling allowing roving immigration patrols in Los Angeles County and the surrounding Southern California region, permitting stops based solely on occupation, language or appearance, is an unacceptable attack on the rights and safety of our residents. The timing of this ruling is especially outrageous, coming at the very start of Hispanic Heritage Month, a time meant to honor and uplift Latino communities and their contributions,” Solis added. “This decision will only intensify the fear, trauma and disruption faced by Angeleno families and neighbors who contribute so much to the strength,

workforce and cultural diversity of Los Angeles County. Racial profiling and stops without reasonable suspicion have no place in our society.”

In a statement of dissent, U.S. Supreme Court Associate Justice Sonia Sotomayor, who voted to continue the ban on immigration raids with Associate Justices Elena Kagan and Ketanji Brown Jackson, characterized the ruling as a “misuse” of the court’s emergency powers.

“We should not have to live in a country where the government can seize anyone who looks Latino, speaks Spanish and appears to work a low wage job,” Sotomayor wrote. “Rather than stand idly by while our constitutional freedoms are lost, I dissent.”

WeHo hotel renovation project faces appeal

an expansion of space where alcohol is permitted. The Standard Hotel permanently closed in 2021 and was designated a local cultural resource after its closing. It sat unoccupied for several years before renovations began.

The appeal, filed against developers Ian Schrager Company and 8300 Sunset Development, LLC, focuses on two exemptions from the California Environmental Quality Act that the Planning Commission granted for the renovations. The appeal alleges that the project's noise level study is inaccurate and does not adequately address potential noise level impacts that would result from the newly renovated rooftop. The appeal also states the project's traffic study did not adequately address parking demands of the hotel at capacity and would congest traffic on Sunset Boulevard.

"In short, the project is likely to generate noise and traffic impacts that will have significant cumulative impacts on residents and neighbors immediately south of the hotel site," the appeal reads. "The city is well aware of the unique noise issues presented with rooftop hotels, which the project's noise study did not adequately consider various factors."

Andrew Brady, a representative

of the Ian Schrager Company, said that the appeal fundamentally misunderstands the purpose of the renovations and that exemptions are often granted to existing buildings undergoing rehabilitation, especially ones of historical status, because they are not as environmentally impactful as constructing a new building.

"The appeal from Unite Here ignores those exceptions and focuses on a bunch of claims related to sort of noise traffic," he said. "All the claims related to noise traffic are fully addressed by technical reports [and] city conditions of approval. The appeal trumps up this argument that it's going to be a big, huge party deck where members of the public can come up and everyone's going to be drinking and making loud noise, and there would be loud parties up there. Nothing could be further from the truth."

Brady added that he believes the union filed the appeal to pressure the hotel into signing labor agreements, rather than out of genuine concern for the surrounding community.

"The objectives of the hotel union have always been very clear," Brady said. "They want hotel operators to sign card-check neutrality labor peace agreements ... So, it's really about their own

professional business objectives. It's not really about these neighborhood environmental concerns."

Unite Here Local 11 did not respond to a request for comment.

During the June 5 Planning Commission meeting, multiple planning commissioners said the renovation was necessary to revitalize the hotel and bring business back to the Sunset Strip.

The West Hollywood Preservation Alliance supports the hotel's rehabilitation.

"The West Hollywood Preservation Alliance urges the City Council to deny this appeal which stymies rehabilitation of a designated cultural resource," said Victor Omelchenko, a member of the West Hollywood Preservation Alliance. "The WHPA supported the Historic Preservation Commission's recommendation for a certificate of appropriateness to rehabilitate this significant mid-century architectural treasure on the Sunset Strip. Approving the appeal would subvert the city's goals for both historic preservation and economic development."

The West Hollywood City Council is scheduled to vote on the appeal on Sept. 15. If allowed to move forward, the renovated hotel is scheduled to open in the second quarter of 2026, Brady said.

Friedman pointed out that voters in California are choosing the state's districting path forward, unlike Texas' legislature who made the move for its citizens.

Friedman's own turf would be slightly altered if the measure is approved, although she would continue to represent most of her current district. While she would gain Afton, Agua Dulce and part of Palmdale, she would lose Sunland and Lake View Terrace.

"I'm simply moving up a little bit to capture some of their population centers. And they have a lot of similar issues that areas that I represent to the south of the Angeles Forest are facing – namely risk from wildfire and issues that they've been having over maintaining and being able to find

insurance for their property – so I do feel equipped to help them with those issues," she said.

Friedman noted that the mid-cycle change to the Congressional map, which typically happens every 10 years in alignment with the federal census, would be temporary as to level the political playing field. In 2030, the process would revert back to California's typical redistricting protocols.

"California has been very happy with our process with the redistricting commission, and we did not choose this particular battle. Donald Trump has chosen," Friedman said. "And as much as we like our process, we have a responsibility to respond. And that is because there is a lot at stake for the people of California that if we

don't have fair representation nationwide, we will continue to see this administration attack our funding for education, people's health care access, the fact that this administration has defunded a lot of California specific infrastructure projects, etc. So, they chose this particular battle."

Neighboring districts would also be slightly altered if voters approve the proposition, though some – like Rep. Ted Lieu's (D-Torrence) district – would remain as is. Currently, Republicans hold a slim majority in the House and U.S. Senate. The 2026 midterms will be the first major referendum of the divisive Trump administration.

"We lose, or we engage them in the arena that they have created," Friedman concluded.




